TRIBAL COUNCIL RESOLUTION No. 2011 - 069

AMENDING RESOLUTION 2000-00111

- At a duly called meeting of the Tribal Council of the Pueblo of Isleta, held on the 18th day of October, 2011, the following Resolution was adopted:
- WHEREAS, the Pueblo of Isleta is a federally recognized Indian tribe with inherent, sovereign powers organized under an adopted Tribal Constitution;
- WHEREAS, the Pueblo of Isleta Tribal Council is the legislative branch of the Pueblo of Isleta tribal government;
- WHEREAS, on October 14, 2000, Tribal Council enacted Tribal Council Resolution No. 2000-00111 "Establishment and Collection of Child Support and Enforcement of Tribal Court Judgments;
- WHEREAS, Section 4.D. of Resolution No. 2000-00111, titled "Withholding and Garnishment of Per Capita Distributions" and states: "Per Capita Distributions shall be exempt from garnishment and withholding from State Court Judgements and from tribal court judgements other than those of the Pueblo's Judiciary, except if such judgement is for the collection of child support. If such judgement is for the collection of child support shall have no force until Section 8 of these provision[s] are applied." (emphasis added);
- WHEREAS, Tribal Council finds that there is a need to amend Resolution 2000-00111 to include judgments for collection of restitution as well as collection of child support;
- WHEREAS, Section 4.D. should be amended as follows: "....except if such judgement is for the collection of child support or collection of restitution." Also, Section 8, titled "Procedures to Domesticate State Court or Tribal Court Judgements to Enforce the Collection of Child Support" should be amended to include "...and Collection of Restitution."

- WHEREAS, the Tribal Council finds it is in the best interests of the Pueblo of Isleta to amend Resolution 2000-00111 as stated.
- THEREFORE, BE IT RESOLVED that the Tribal Council hereby amends Section 4.D. to read: "....except if such judgement is for the collection of child support or collection of restitution."
- **BE IT FURTHER RESOLVED** that the Tribal Council hereby amends the entirety of Section 8 to include "... and collection of restitution" after "collection of child support".
- **BE IT FINALLY RESOLVED**, that this amendment shall take effect immediately upon adoption of this Resolution.
