DESIGNATION OF HISTORIC SITES & PATHS AND AMENDING RESOLUTION NO. 2011-042

At a duly called meeting of the Tribal Council of the Pueblo of Isleta held May 16, 2013 the following resolution was passed:

WHEREAS, the Pueblo of Isleta is a federally recognized tribe and the Tribal Council is the governing body of the Pueblo of Isleta;

WHEREAS, the Tribal Council recognizes a rapidly changing environment in the Pueblo due to its own growth as well as the growth of neighboring communities;

WHEREAS, in response to such change, the Pueblo of Isleta is undertaking community planning to preserve the culture and traditions of the Pueblo while enhancing its physical, environmental and economic environment;

WHEREAS, the Tribal Council further believes that it is in the best interest of the Pueblo to protect from development and preserve and maintain in perpetuity certain sites of historic significance, and certain paths of historic significance that were, are, and are to be used for cultural activities as well as for daily community activities.

WHEREAS, Tribal Council adopted Resolution 2006-114 and rescinded it with Resolution 2011-042 and now wishes to amend with this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the Pueblo of Isleta officially designates the previously above-referenced sites and paths as the Historic Sites and Historic Paths of the Pueblo of Isleta, and in addition wishes to add to this resolution the Historic Sites and Historic Paths attached herein, to include amendment to HP-3, HP-16, HP-22, and HP-24, and to include a new HP-30, HP-31, and HP-32, as described in the revised map (Exhibit A) and Description of Historic Sites and Historic Paths (Exhibit B).

BE IT FURTHER RESOLVED, that the Tribal Council hereby declares that under no circumstances are non-Indians permitted to be on the Historic Sites and Historic Paths.

BE IT FURTHER RESOLVED, that Tribal Council Resolution 2011-042 is hereby amended with this Resolution.

BE IT FINALLY RESOLVED that the Tribal Council authorizes and directs the Pueblo's attorney to draft certain provisions to be added to the Pueblo of Isleta Law and Order Code to implement the intent of the foregoing resolution, and the Realty Department to survey and record such lands.



Description of Historic Sites ("HS") & Historic Paths ("HP")

Amendments approved by Tribal Council on May 16, 2013 in red.

- HS-1. Mesa located west of I-25 & east of NM 45, & mesa located east of I-25 & west of NM 45.
- HS-2. Inside boundaries of Isleta Eagle Golf Course, one located between Mesa Nine 1 & Lakes Nine 1 & east of lake; the other located south of Mesa Nine 2 & north of Lakes Nine 7.
- HS-3. Church and Church yard.
- HS-4. Ash mound located south of Lupita Jiron residence & TR 35.
- HP-1. Northwest corner of Plaza between Carmel Lucero & Carlos Zuni residences.
- HP-2. West of Church between Phillip Padilla & Geronimo, residences.
- HP-3. West of TR 40 between Tommy Lente & Louise Chewiwi residences continuing west over the railroad across 314 south to cement ditch and northwesterly along the ditch to Coors Road.
- HP-4. South of the late Al Sangre's residence.
- HP-5. Southwest of Plaza between Terry Lente and Leona Lente residences.
- HP-6. Southwest of Plaza, south of Terry Lente residence all the way west to TR 42.
- HP-7. Southwest corner of Plaza, west of Tony Lucero & Juana Jiron residences, north of TR
- HP-8. From HP 7 west to TR 40 & south of Joe Juancho residence.
- HP-9. East of Lola Peigler residence & west of Regina Toya residence & Tribal storage.
- HP-10. South of TR 41 & north of TR 37, east of Denise Wade residence & west of Rosenda Cata yard.
- HP-11. South of TR 41, north of TR 37, east of Franco Chavez & Evelyn Ankerpont residences & west of Virginia Shupla residence.
- HP-12. Southeast corner of Plaza, east of old Tribal Court House & west of Eugene Lucero residence.
- HP-13. North of Lupita Jiron residence & south of the late Juan B. Abeita residence.
- HP-14. East of Plaza, east of Gloria Zuni residence & west of the late Steven Lente residence.
- HP-15. East of Plaza, west of Gloria Zuni residence & east of Margaret Zuni residence.

Description of Historic Sites ("HS") & Historic Paths ("HP")

- HP-16. South TR 36 from TR 33 along east side of ditch bank continuing south from Mathew Zuni residence south along eastside of ditch bank across the canal and south ¼ mile and crossing east to Rio Grande
- HP-17. West side of Stanley Jojola residence, south to TR 37.
- HP-18. South side of TR33, south side of Martha Jojola residence.
- HP-19. Southwest corner of TR33 and TR39 by Martha Jojola residence.
- HP-20. East of Round Kiva on TR41 and TR35 to west side of Rita Jojola residence.
- HP-21. South of TR35 between Perfecta Jojola and Pauline Valardez residences, and east of between Dora Jojola & Juan Chavez residences.
- HP-22. East side of NM147 on TR 31 north of TR 35 between Dorothy II and late Remijo Chewiwi residents to vacant lot east side of NM147 on TR34 along ditch bank and over ditch culvert to vacant lot on the right.
- HP-23. Between TR34 and TR35 between, east of Angel Jojola & Norbert Lucero residences, and west of Roberta Zuni residence.
- HP-24. East side of TR32 in front of Maria Lucero residence, and north along cement ditch bank and continuing north from 147 along eastside of ditch bank(between Delano Jiron residence on eastside and Simon Abeita residence on the west) to BNSF Black Bridge.
- HP-25. From northwest of Plaza on TR45 north to NM147 intersects with HP26.
- HP-26. North of NM147 on TR88 along east side of ditch bank.
- HP-27. TR78 from NM314 to NM45.
- HP-28 West of Tr78, south side of Cleo Jojola residence and north side of Joseph Lucero residence, to cement ditch bank.
- HP-29 East of TR76, south side of Jacob Abeita residence, to cement ditch bank.
- HP-30 Tribal Rd. 35 southeast of plaza east on TR 35 across the Rio Grande to TR Rd.12 and Indian Service Rd. 624-and east on TR. 14 to Manzano Mountains.
- HP-31 Off of East NM147 onto TR33 west side of MRGCD Dam and across the walk bridge to the Rio Grande River
- HP-32 Off of TR 80 North on TR661
