Governor's Report

First of all, we in the Governor's Administration want to Wish Each and Everyone of You and Your Families a Very Merry Christmas and a Happy New Year!!

We want to thank all the community members for taking time to vote during the federal, state and tribal elections. It is important that you vote, as each vote is critical. Tribes throughout Indian Country vote in hopes of electing candidates who will support Native American issues such as water rights, healthcare, education, law enforcement and other issues.

The Pueblo of Isleta chose not to endorse any candidate running for tribal, state or federal office. It is best to leave the decision up to the individual for whomever they wish to cast their vote. Without endorsing any candidate, Isleta did allow a number of candidates, both Democrats and Republicans, to campaign and hold political rallies and forums in Isleta. It is important that this be allowed so that our tribal community will be informed how these candidates will support Native American issues and concerns.

I was appointed to the transition team on Indian Affairs by newly elected Governor Susanna Martinez. This is an important position for Native Americans as we will be working and advising on saving and filling critical positions within the New Mexico Indian Affairs Department. This is not a paid position, and will end at the year when the new Governor is sworn into office in January 2011. I want to congratulate all the newly elected officials at the tribal, state and federal level.

The waterline project is complete but with a few minor additions to the project continuing. The church project is on-going and will hopefully meet its deadline. There was a concern after a portion of the southwest wall by the choir sheered off. Safeguards have been installed to prevent further delays to the project. The judicial complex is on schedule and the road project for entry into the complex is near completion.

DEPARTMENT OF NATURAL RESOURCES NEWS

CONGRATULATIONS to Arnold Chavez and Michael Abeita

On June 11, 2010 Department of Natural Resources Employees, Arnold Chavez and Michael Abeita successfully completed the sixteen week long Land Management Police Training Program at the Department of Homeland Security's Federal

Law Enforcement Training Center in Artesia, New Mexico. Both employees were also certified in Wildland Fire Observations and Origin Scene Protection for First Responders (FI-110). In addition, Arnold and Michael completed the 40 hour BIA Police Follow-on Training Program, meeting the basic law enforcement training requirements on June 18, 2010. These Police Training programs set high standards of proficiency requirements that must be met in physical fitness, self defense tactics, firearms skill, driving, and criminal law. Out of a class of 26 students, Arnold and Michael were two of the 18 who successfully completed both Programs.

With completion of both programs, Arnold and Michael are the first fully certified Pueblo of Isleta Wildland Law Enforcement Officers (WLEOs) in the Resources Protection Division of the Department of Natural Resources. Arnold holds the position of Lieutenant WLEO and directly supervises Michael and two other employees, Dereck Lujan and Daniel Jiron who will also attend both law enforcement programs within the next 12 months.

The Wildland Law Enforcement Officers are directly responsible for patrolling the mountain forests, rangelands, bosque, and pinyon-Juniper woodland areas in order to protect all natural resources (wildlife, vegetation, cultural sites, etc.), Tribal

member safety and Tribal property (boundary fences, rangeland facilities, etc.) by dealing with criminal activities such as poaching, illegal dumping, trespass, fire arson, etc., through enforcement of Pueblo of Isleta Law and Order Code, federal regulations, and state laws. The WLEOs also coordinate and cooperate with the Isleta Police Department and other federal/state law enforcement agencies as part of their duties.

COMMUNITY NOTIFICATION

Registration of Convicted Sex Offenders

TO: ANY AND ALL CONVICTED SEX OFFENDERS WHO RESIDE, ATTEND SCHOOL, ARE EMPLOYED WITHIN THE EXTERIOR BOUNDARIES OF THE PUEBLO OF ISLETA OR VISIT WITHIN THE EXTERIOR BOUNDARIES OF THE PUEBLO OF ISLETA FOR OVER 24 HOURS; OTHER PERSONS SUBJECT TO THE JURISDICTION OF THE PUEBLO OF ISLETA; AND COMMUNITY MEMBERS

The Pueblo of Isleta Police Department is dedicated to registering convicted sex offenders and providing community notification to protect the public. The Pueblo of Isleta Public Sex Offender Registry is located at: http://isleta.nsopw. gov/ From this public registry, community members are able to obtain information regarding convicted sex offenders within their community. Additionally, this public registry allows any person to request email notification of the relocation of any sex offender back to the person's community.

If you are a convicted sex offender (Indian or Non-Indian, convicted of a sex offense in Isleta Tribal Court, State of New Mexico courts, other state courts, federal court, military court, and any other court) and if you have not registered with the Pueblo of Isleta, your failure to comply with registration is an offense under the Pueblo of Isleta Sex Offender Registration Ordinance, which provides: Each violation ... by a sex offender who is an Indian shall be considered a crime and subject to punishment as a Class A Offense and in no event punishable less than the maximum penalty imposed by a Class B Offense Civil Penalty. Each violation ... by a sex offender who is not an Indian shall also be considered a civil violation subject to enforcement by any means not prohibited by federal law, including, but not limited to the following:

1.Issuance of fines in these amounts:
\$1,000 for the first offense; \$2,000 for the second offense; \$3,000 for the third offense; and \$4,000 for the fourth offense.
2.Civil contempt, and
3.Banishment in accordance with Pueblo of Isleta law.

Ordinance at Ch. 8. Furthermore the Pueblo of Isleta Sex Offender Registration Ordinance makes it a crime to (1) knowingly or attempting to harbor a convicted sex offender,
 (2) assist in eluding law enforcement, or

(3) provide false information to law enforcement about a convicted sex offender. Id.

TRAFFIC DIVISION NEWS Isleta Police Department Traffic Division

The Christmas Season is now upon us and we are all thinking of our Christmas shopping, dinner preparations, Christmas card mailings and thousands of other tasks that come with the season. Also with the season comes "Schools Out" and the children are out and about. Please be aware and drive carefully throughout the Pueblo watching our for our youth.

The Traffic Division has had a few changes since the last newsletter article submitted and here is a quick update. The division now consists of Officer Sharon Mitamura who was promoted to Supervisor/Lead Traffic Officer; Officer Darryl Chavez, and our newest officer, Officer Tim Zuni, joined the division in mid-July. We have also added an honorary junior officer as of October 17, 2010, when Miss Madison Zuni was born. CONGRATULATIONS TO THE PROUD PARENTS!!

The goals of the division are to ensure safety on the roadways throughout the Pueblo and traffic enforcement is key in accomplishing this end. So please obey all traffic laws - observe speed limits, watch for construction being done on State Road 47, obey traffic signals, traffic signs, etc. The Traffic Division and patrol officers will be out in force during the holiday season to ensure everyone enjoys a safe and joyous holiday season.

As part of the division's traffic enforcement duties, the officers will be participating in several mobilizations with the first being "DON'T SHATTER THE DREAM" which will begin December 20, 2010 and run through January



3, 2011. This mobilization is conducted by BIA and tribal law enforcement in Indian Country through January 3, 2011. The "Don't Shatter the Dream" Indian State Impaired Driving Mobilization is a joint effort by the BIA's Office of Justice Services (OJS), the Indian Affairs Indian Highway Safety Program (IHSP) and the U. S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) to reduce injuries and save lives. The campaign seeks to send a message across Indian Country that driving while impaired will not be tolerated throughout the holiday season, and that tribal officers are on alert to protect drivers on reservation roadways.



Hello from the Comanche Ranch

We have reached the end of 2010, and we are looking forward to the New Year 2011. The ranch has had a good calf crop this year, our steer calves averaged \$665.00 per head and our heifer calves averaged \$564.00 per head.

Out of 900+ cows we had a 80% calf crop this year so far, and we still have about 100 fall calves yet to brand which we will be doing in December. We were able to save about 80 top choice exceptionally nice replacement heifers.

This year we had to get rid of some old cull cows do to no teeth, old age, bad eyes, and not bred. We preg. checked most of the ranch cattle and they are bred back, we'll be in the high 90% due to good moisture and grasses this year, as well as the feed supplements that they were given. We only had to feed 25% out 100% due to the good forage the ranch got this year.

At the end of 2010 the Ranch Cattle Inventory will be right at about 1000 Breeding Cows, and 100 fall Calves as well as 75 Bulls.

As the manager of the Comanche Ranch I took over 4 years ago, and as now I have got the calf crop up from 30% to 90%, I feel like we have come a long ways in the quality of cattle we are running now but still feel like we can do better and there is room for improvement .

I am very proud to say we have made it in the New Mexico Stockman magazine twice this year and the Comanche Ranch is getting recognized throughout the Southwest and other parts of the United States as Native Cattle Producers. If anyone would like a copy of the New Mexico Stockman there will be copies at the governor's office.

The Council has passed a resolution to combine the Farm Conservation Enterprises with the Comanche Ranch, the council ask me to put a Farm & Ranch plan together to combine the two. I worked with a consulting firm called Blue Stone Strategy group we put together a 21 page plan, we are trying to bring the two together to utilize more of the feed from the farm to make it more of a profitable resource for both entities, we are trying to get the farm to be more profitable in the near future.

As of now the ranch is starting to show a profit each year, now with the two being combined we expect to show a profit with the Farm Conservation as well.

This is a 24/7 position and I am always seeking and working towards ways of improving as far as USDA Grants, NRCS (United States Department of Agriculture) this year we got roughly received about \$60,000 in grants for ranch improvements.

For the year 2011 I am currently working on getting grants for the farm and ranch both.

When I received the promotion to manage the farm as well as the ranch, I received a pay increase to compensate the responsibilities and work load I have to carry, during the election there were several allegations made that I am receiving \$95,000 a year which is totally untrue. As the manager of the Comanche Ranch and the Farm Conservation I will do my very best for the Pueblo of Isleta and its people to make both of these entities profitable in the years to come.

I would like to thank the tribal administration for their support throughout the year, I would also like to Thank TaTa Fred with Range Patrol for taking the time to come out to the Comanche Ranch and help with our cattle works and ranch improvements.



Well, three Holidays (Halloween, Per Capita, & Thanksgiving) have passed and we got two more (Christmas & News Years) then we can all look forward to the Big Pay Day from Meh-Meh Sam in the form of a Tax Return. In the mean time, why don't you grab another blanket, throw another log on the fire, or scoot a little closer to the heater while you read the library's section of the Newsletter.

NEWS:

The month of December will be somewhat tricky for our Hours of Operation due to the Holidays and Traditional Dances. Here is our latest Operational Hour schedule for the month of December.

CLOSED:

Thursday, **December 24** in observance of Christmas Day.

Thursday, **December 31** in observance of New Year's Day.

Library Winter Hours:

Monday & Tuesday, December 20 & 21, the library will be OPEN from 8AM – 6:30PM.

Starting December 22 through December 30, the library will OPEN from 8AM – 4:30PM.

It was brought to my attention in the month of November that the New Mexico Motor Vehicle Department (MVD) has stopped issuing Drivers Manual. Individuals hoping to obtain their N.M. Drivers License are directed to the M.V.D. website to download the Drivers Manual. So, to make life easier on everyone, we have downloaded both the English & Español manuals (3 English & 2 Español) and put them on our shelves for individuals to borrow while studying for the test. However, if the individual(s) should lose or not return the manual(s) they will be charged a fee of \$15 to cover the cost of colored paper & binder.

As reminder, the library also has the *None* For The Road: DWI Awareness Program DVD, which all individuals seeking to obtain their Drivers License must watch. These DVDs are part of the Reference Collection which means these are NOT allowed to leave the library premises for two reasons: 1) Previous copies were borrowed and NEVER brought returned and 2) The librarian must sign and stamp the individual's booklet after the individual has watched the DVD. All computers in our community computer lab have a DVD drive which allows one to watch the DVD with headphones. The only thing the library does NOT offer is the actual Driver's Test, so enjoy sitting in the waiting room of the MVD. Good Luck!!!

Since we are on the topic of vehicles, let me take this time to remind everyone that the library has an extensive collection of Chilton's Auto Repair Manuals ranging from 1986-2011. Manuals are for all makes and models known to mankind unless it is a "Frankenstein Vehicle" and has been pieced together. All Chilton Auto Repair Manuals are part of the Reference Collection which means they are NOT to leave the library premises but we will be more than happy to make you Xerox copies.

Attention Guitar Players: The library has just received another huge order of Guitar Tablatures. This time around the Tablatures are more diverse, consisting of Country Artists such as Taylor Swift to Alan Jackson, and New Alternative Artists such as the Yeah Yeah Yeahs, The Black Keys, and Paramore. If you are interested in obtaining a FREE computer all you have to do is submit a 2 page essay to the library, stating how a computer would enhance the lives of you and your family. Computers are used PCs from the library and other departments. For further information, feel free to call the library and speak to a library staff member.

The library will be conducting Christmas Activities on three nights in December; they are December 13, 14, & 16 from 4:30pm – 6pm. Supplies are limited on a first come, first serve basis and the activities are open to all patrons of all ages.




Karate

YOUTH Suicide & Substance Abuse Prevention

Isleta Behavioral Health Services (IBHS) submitted a grant proposal to OptumHealth New Mexico for Suicide and Substance Abuse Prevention services for at-risk Native American Youth and was chosen for funding. The total 3-year funding award is for \$177,740.00 and is expected to reach 60+ Isleta Pueblo youth between the ages of 10-18 years.

The first objective is to implement an in-school substance abuse prevention curriculum for grades 6th-9th at four selected schools. Youth will develop positive life skills including risk assessment, decision making, refusal and drug resistance skills, while enhancing anti-drug norms and attitudes.

The next objective takes a look at Historical Trauma and how past events have taken a toll on our Pueblo community, particularly youth and education. By using culturally appropriate interventions and incorporating indigenous values and practices protecting against drug use, youth will create a stronger self and community based on youth driven advocacy and policy change.

The following activities will be implemented:

- Outdoor activities: SNOW BOARDING, STAR GAZING, HIKING, MOUNTAIN BIKING, CAMPING, ROPES COURSE, CULTURAL SITE VISITS and RAFTING
 - COMMUNTIY GARDENING
 - YOUTH PHOTOGRAPHY
 - INVITED COMMUNITY GUEST SPEAKERS
 - Trips to WAREHOUSE 508 and other youth driven coalitions and community centers

Domestic Violence Prevention Initiative

After conducting a community needs assessment IBHS submitted a proposal to Indian Health Services and received over **\$250,000.00 to address domestic violence in Isleta Pueblo.** The target population for advocacy services will be survivors of domestic violence and the community at large with prevention activities focusing on service providers, tribal law enforcement, tribal courts and interested community members.

Funding will be used for the following:

- Employ 2 part-time victim advocates
- Provide the Isleta Community with a Domestic Violence Summit
- Coordinate efforts amongst existing agencies to create a more integrated and consistent response to domestic
- violence problems in the community and
- Coordinate training for first responders to domestic violence calls

On June 7th IBHS hosted a meeting with representatives from Isleta Police Department (IPD), Isleta Social Services (ISS), Isleta Tribal Courts (ITC) and Isleta Head Start (IHS). Johnson-O'Malley Program

Greetings from the staff of the Johnson-O'Malley Program. We hope everyone is doing great. The hustle and bustle of the holiday season is at hand as we prepare for the end of the 2010! We have plenty of wonderful activities planned for our Native American students and their awesome families. We are working diligently to end our contract year on a positive note. We have faced many challenges since the beginning of the school year and have the strength, commitment and dedication to push right through. Here is a rundown of all the services that we have provided since the beginning of the school year:

A little JOM History: Not Just School Supplies

As many of you all discovered at our back-to-school mandatory meetings, JOM is so much more than just school supplies. At the beginning of the school year we requested all parents meet with us either at one of the scheduled meetings or individually. During these meetings we informed parents about the history of the Johnson-O'Malley Program and why it is so important for parents and students to become involved in the program. For those of you that are not aware of what JOM is about, here is a brief history explaining what the Johnson-O'Malley Program is.

The Johnson-O'Malley Program is a federally funded program that provides educational support to meet the unique and specialized needs of Native American students enrolled in Public Schools. The Johnson-O'Malley Act was signed over 75 years ago. One of the original intents of the JOM Act was to supplement finances for public schools that provided educational services to Native American students. Why was this important? Well, for public schools to provide educational services to Native American students they needed supplemental funds. As we are all aware Indian Reservations are tax-exempt, which means those Indian students living on reservations and attending public schools did not generate money for the school districts. So the federal government decided to assist school districts financially, this also "encouraged" school districts to accept and educate Native American children. So you still have questions? Let us explain a little more...

the history of Indian Education As transpired, the Johnson-O'Malley has contract has grown into what is known as a "Self-Determination" contract. A "Self-Determination" contract is a contract, which allows the implementation and accountability to shift from outside a Native American community to the actual Native Community involved or affected. Also, as a component of "Self-Determination" we have a true interest and investment in the education of our children, we know what is best for our children. It gives us the ability to empower our parents and our students. We, as parents, know what goals we would like our children to reach. It allows us to create a path to work towards those goals. It is our duty as parents to decide what types of services our students need to reach academic success. Many school districts will obtain the JOM contract. The Los Lunas Public Schools does not hold the JOM contract due to the fact that the Pueblo of Isleta has that contract. Under

our contract we serve all Native American students enrolled in the Los Lunas Public School district and only the Isleta students enrolled in the Albuquerque Public School District. APS also has a JOM contract.

Our contract year begins January 1 and ends December 31. The process of applying for a contract begins in August. Under the federal guidelines we are required to have input from parents, this is met by requiring parents to complete a needs assessment. In August, as a part of the school supply distribution we request parents complete the Needs Assessment. Based on the Needs Assessment the foundation for the new contract year is put in place. An educational plan and proposed budget is created in collaboration with the Indian Education Committee (IEC). The IEC is a group of elected parents that assist in the planning and execution of the JOM contract. By October 31 the proposed contract and budget is forwarded to Bureau of Indian Education (BIE). The educational plan and proposed budget wait approval. When the President's Budget is approved and our contract is granted we will receive a letter from BIE informing us of the approval and amount of the award. This normally occurs in January. Last year the award amount for JOM was \$55,415. Our JOM Program has approximately 750-800 eligible students. This breaks down to about \$69.00-\$74.00 per student, not very much for an entire year of services. As our contract year winds down here are a list of services we provide: Back to school supply distribution, tutoring, educational trips, liaison services, and reimbursements.

Whew...so much information in such little time. We could go on and on about the history of JOM but there are other things we would like to share with you.

School Supply Distribution

At the beginning of the school year we gave school supplies to over 435 students. We provided cinch sacks and water bottles that sported the JOM logo and contact informationto all these students. In addition to the basic school supplies we also provided close to 25 students with TI-83/84 calculators. These calculators are quite expensive and can cost up to 125.00/each. Based on last year's numbers we planned on providing supplies for about 300 students which was about 50 more students. We ran out of supplies and made another purchase for additional supplies. It was great to see an increase in the number of students that received school supplies. There are students out there that have not received their supplies; we have a few supplies remaining. You are more than welcome to come by and pick up supplies if you have yet to do so. It was awesome to provide supplies for so many students.

Tutoring

Our tutoring program seemed to have its own hang ups early on. Over the summer months after the summer programs ended the tutoring building became home to some unwanted guests. We had some mice take up residency in the tutoring building and due to the health risks involved with the mess they made we had to begin tutoring a few weeks later than what we would have liked. We had a professional cleaning company come and decontaminate the facility and remove hazardous material that these rodents left behind. To end on a positive note! We have successfully provided tutoring services to several students. We have also added another block to the tutoring schedule. This block runs from 5:30- 6:30pm Monday thru Thursday. We have also purchased additional educational games and resources for students to utilize. Parents and students are more than welcomed to come to the tutoring center to utilize any of these awesome games that support learning.

Educational Trips

It is our goal to provide students with experiential learning opportunities. For many of our students going and visiting places that they have never been is one of the best educational experiences ever. We took a group of students to Chama to ride the Cumbres & Toltec Railroad. Our students learned so much from this experience. They learned how the trains operate, the importance of train/railroad communication and the history of the railroad in Northern New Mexico. We rode the train to Ossier, Colorado and back to Chama, NM. They enjoyed a wonderful lunch and were able to meet and spend time with students from other schools.

In November we had the pleasure of taking students to Bodies the Exhibition being held at the Albuquerque Convention Center. It was a wonderful way to expose students to actual human bodies and the body systems. We asked that parents use their own discretion to determine if their student would be respectful and appreciate such displays. The students that participated on this trip are interested in the medical field or had other interests as it may have pertained to family illness and such.

We had seven students total, four were high school students and three were in middle school. We planned on taking students to the National JOM Conference in Billings, Montana in October. However, the approval process took quite a bit longer than we expected. We received word three days before the conference that travel was approved. Students, parents and staff had given up and were not ready to attend this event on such short notice. We decided that these students will attend next year's National JOM Conference. True disappointment!

We have several interesting educational trips in the planning stages and more information will follow soon. Students that attend trips are required to complete a mini-project or report about what they have learned.

Reimbursements

Reimbursements for the beginning of the school year are coming to an end, if you are requesting a reimbursement for the first semester of school these must be submitted as soon as possible.

Reimbursements include ACT fees, SAT fees and Lab Fees. The **original receipt** from the school must be submitted to the JOM office as soon as possible. It can take up to two weeks to receive a reimbursement. We must have a CIB on file to process a reimbursement.

In October, we held our first family activity night for this school year. Students and their parents were invited to the JOM tutoring center for an evening of exciting games and fun activities. Evervone enjoyed games, even the adults! We had a race to wrap the perfect mummy. Teams of two were timed and required to wrap one another with rolls of toilet paper to make a life size mummy. We had lots of laughs! The other game geared for adults was the doughnut eating contest. Contestants were required to eat a doughnut hanging from a string with no hands. If the doughnut dropped the contestant was disqualified. Everyone had such an awesome time with plenty of laughs.

In November, we had a Thanksgiving Activity night, we provided a wonderful Thanksgiving Dinner to all that attended. Students made placemats for Thanksgiving and wrote their recipe for how to cook a turkey. They also decorated mini-people paper cut-outs and included what they were thankful for. We also held our parent meeting this same evening.

No Joke, This Really Happened

Halloween weekend the Over Old Elementary School was broken into and vandalized. The damage was severe. This is the third time that this building was the target of such ruthless, disappointing and unbelievable acts. The first time the building was broken into was towards the end of summer. The vandals gained entry and dispersed several fire extinguishers in the main hall. Unfortunately, Teacher Barbara from the Language program was forced to move her class outside to the grassy area to conduct her instruction. The toxic chemicals were too much to be around. Thankfully hazmat was able to take care of the hazardous chemicals and residue left behind from the culprits.

Within one week they hit again! The second time these individuals entered the building they targeted the classroom that Teacher Barbara was using. The individuals stole snacks from the classroom that were purchased for the students participating in the language program. All the children were disappointed and upset that someone would steal from them.

The third break in occurred over Halloween weekend. On Friday, October 29, the JOM Program had an activity night in the tutoring building. Before leaving the premises we did a complete check to ensure that everything was locked up. Upon returning on Monday, we discovered that once again these same ruthless and disrespectful individuals came back. This time they caused an excessive amount of damage to the JOM Administrative office and the classroom used by the Boy scouts, not to mention the halls. These individuals got their sticky fingers on fire extinguishers. They gained access to our office, sprayed fire extinguisher in every corner including all over the computers and desks. These sticky finger culprits also stole several items from the JOM Administrative Office. They stole several Ti-83/84 calculators, a green camera, an I-pod dock (pink, white and black), and several sets of Bic Mark-It Markers, Sharpie Highlighters, a computer headset, a large unopened container of coffee and a juice box. They also stole several tents from the Boy scouts classroom. The cost of cleanup was tremendously high.

It is particularly disappointing because it appears that the individuals are from within our own community. On several occasions there have been groups of teenage boys and girls in or around the area of the Old Elementary. As parents, it is most definitely OUR responsibility to know where our children are and what they are doing, no matter the age. There seems to be more and more students roaming around from program to program with no intent to participate. IF your teen says they are involved in certain programs, contact the programs directly to make sure the student is where they are suppose to be. Here at the JOM Office, tutoring is provided on a signup basis. Students are assigned a time to come and receive services. These sessions are only 1-hour long.

Webelieve that students from our community know who is behind these callous acts. It's not humorous and it's definitely not cool. The programs affected are here for the children. You are essentially hurting the community and your peers when malicious acts such as these take place. If you have any information regarding the break-ins, please contact the Isleta Police Department.

Participation is available on a first come first serve basis. Dinner will be provided prior to attending this event.

Once again the J.O.M Program will be having a Christmas Activity/Literacy Night. We will be having arts & crafts, games, and of course Santa will be here! Families of J.O.M eligible students can stop by and enjoy good times and even take a picture with Santa Claus. As we did last year, we will have books available for students in all reading levels. We believe that every student should have a collection of books at home to practice and improve their reading. The book that they receive from J.O.M can be the start of their library or an addition to one they already have!

We are also working with Jennifer Padilla and Juan Rey Abeita from Isleta Behavioral Health Services to develop an intervention/ prevention program to help youth cope with suicide and drug use. Imagine your child two years from now, five years, ten years, as an adult. What do you want for your child? What do you want your child to learn? What kind of person do you want your child to be?

The Early Head Start home-based program option was created to help you help your child reach these goals—and others you may not have dreamed of yet. We believe in you! We are here to support you.

Once a week, a home visitor will come to your home. Your home visit will last 90 minutes. You, your spouse or partner, your child's brothers and sisters, and any other household members can all take part.

You will talk together about your child and how things are going for your family. Together you will plan activities for you to do with your child during home visits and during the week between visits.

Over time, as you get to know one another, you will become partners in helping your child grow and learn.

Twice a month, you and your child will meet with other children and parents. You will have time to get to know one another and share interesting experiences. Your home visitor will be there too. We call these meetings "socializations." You can also take part in the program in other ways. One of the special things about Early Head Start is that mothers and fathers are truly involved. Your program, like every Early Head Start program, is designed to meet the needs of its children, families, and the community.



Your program will look to you and other parents for ideas to help shape the program policies and experiences for children and families.

We are looking for children ages 0-35 months who are Isleta Native/Descendant or who reside on the reservation. We have several slots waiting to be filled by families in this community.





WIC NOTES

They're here again...the holidays that is. With the holidays come family, friends and food. An unwelcome visitor can also make an appearance... food poisoning.

You may have heard of the salmonella outbreak this summer that led to the recall of eggs in many parts of the country. Safe food-handling practices include:

• Eggs should be cooked thoroughly, until the whites and yolks are firm.

• For dishes containing eggs the internal temperature of the dish should reach 160 degrees F.

• Thoroughly clean your hands, as well as the surfaces and utensils that come into contact with raw eggs - an important step for avoiding cross-contamination.

• Separate eggs from other foods in your grocery cart, grocery bags and in the refrigerator to prevent cross-contamination. • Keep eggs in the main section of the refrigerator, not the door.

The temperature of the refrigerator should be between 33 and 40 degrees F.

• Eggs accidently left at room temperature should be discarded after two hours, or one hour in warm weather.

Here is the recipe from this month's WIC Nutrition Education Class. It is so tasty we wanted to share it with the entire community.

WIC Pumpkin Bread. Makes 1 loaf

Ingredients: 1-3/4 cups all-purpose flour 1 tsp. baking soda 3/4 tsp salt 1 tsp nutmeg l tsp cinnamon 1-1/2 cups sugar 2 eggs, beaten 1 cup of fresh pumpkin OR 8 ounces of canned pumpkin • 1/4 cup water if pumpkin is fresh OR • 1/3 cup water if pumpkin canned

1/2 cup vegetable oil 1/2 cup chopped pecans

DIRECTIONS: Preheat oven to 350 F. Combine flour, soda, salt, cinnamon, nutmeg and sugar in large mixing bowl. Add eggs, water, oil and pumpkin. Stir until blended. Add nuts. Mix well. Pour into two 9x5" loaf pans. Bake 1 hour. Cool slightly and take out of pans to let cool on a rack. This tastes best if you wrap, refrigerate and wait a day to eat it. It keeps well in the refrigerator and can be frozen.

Christmas Dinner Game: Thankful 4s

We spend so much time preparing for Christmas sometimes the true meaning of the holiday gets lost. Here is a fun game you can play with your entire family that will remind us all to count our blessings.

1. Cut large number 4s from paper (almost any kind of

- paper will do i.e. printer paper, construction paper.
- 2. Place one on each person's plate.
- 3. Just before dinner, have everyone write the things they are thankful for on their cutouts.
- 4. Go around the table and take turns sharing your list.

For a festive way to display your family's Thankful Fours, punch holes in each one, tie on a ribbon or string, and hang your creations from the Christmas tree, or light fixture, along a banister, or in a window.

If you do not follow these 3 requirements, you may be held Financially Responsible for any charges incurred at Quick Care.

Quick Care

Located: 1400 Main Street, Suite D in Los Lunas at the intersection of Main Street and Los Cerritos in the shopping center behind Quizno's.

Open: Monday through Friday until 9pm and Saturday & Sundays 10am -6pm

Need: Pueblo Census ID Card, which shows "I" Number (Financial Assistance can only be provided to enrolled tribal members and their Native American [minor] children and spouses.)

QUICK CARE is an URGENT CARE Service and should not be used for routine medical needs; it is not an emergency room. If the Nurse Advice Line recommends you go to an emergency room, then do so and report it to Contract Health within 72 hours. Individuals with insurance coverage should follow the rules of their coverage and may not be eligible for this Quick Care service.

HEALTH SERVICES CONTRACT HEALTH SERVICE NOTICE TO ALL PATIENTS BEING REFERRED BY ISLETA HEALTH

CENTER TO CONTRACT HEALTH PROVIDERS A patient may be referred by an Isleta Health Center doctor or dentist when the service needed cannot be provided at Isleta Health Center.

A referral to another health care provider-DOES NOT GUARANTEE that Contract Health Services (CHS) will authorize payment. Payment authorization is separate and dependent upon the individual's eligibility for the CHS program, the CHS care priorities, and the patient's coverage by or eligibility for alternate financial resources.

Alternate financial resources include private insurance, Medicare, Medicaid, Workers Compensation, motor vehicle insurance, Veterans Administration, Children's Medical Services, etc.

Individuals who are determined to be ineligible under the CHS Program WILL BE RESPONSIBLE FOR PAYING any expenses incurred with a health care provider via the referral.

Eligibility under the Isleta CHS Program is determined by a number of factors, including enrollment as a member of the Isleta tribe, residence on or near the Isleta reservation, age (minor/adult status), and marriage to an enrolled Isleta member.
