#### **Summer Irrigation**

The month of March finds our pueblo farmers getting ready for the planting season. The outlook for irrigation water does not look very promising. We currently have sufficient water, although, we are not sure if it will last for the entire season. We pray that the Great Spirit will bless us with plenty of rain to help us through the year. I will let all of you know of the water availability each month as we progress through the season.

#### **Pueblo of Isleta Community Meeting**

I am happy to inform everyone that our first community meeting, this year, will be on April 27th at the Hard Rock Albuquerque Casino Showroom from 9:00am to 12:00pm. I have plans to have at least three community meetings this year. I hope all of you can attend this first scheduled meeting.

#### Lieutenant Isidor Abeita attends the National Congress of American Indians

On March 5, 2013 thru March 8, 2013 Lt. Abeita attended the 113th National Congress of American Indians (NCAI) held in Washington, DC.

The 113th Congress got off to a fast start with the passage of key legislation to advance tribal sovereignty and improve the welfare of Indian and Alaska Native people. In an historic vote on February 28th, the House passed the Senate version of the reauthorization of the Violence Against Women Act including the restoration of tribal criminal jurisdiction over all persons who commit acts of domestic violence, dating violence, of violations of protection orders within Indian country. In January, Congress passed the Sandy Recovery Act of 2013, including an amendment to the Stafford Act where tribal governments now have the option to seek a federal emergency or major disaster declaration directly from the President of the United States.

It has been an extraordinarily successful start to the 113th Congress, and there are many Members of Congress, as well as the Administration, who deserve our sincere thanks. The success comes with broad support from both Republicans and Democrats, emphasizing the importance of bi-partisan engagement. Most importantly, tribal leaders and advocates have worked together cooperatively to educate Congress and the Administration. Let's keep up the good work together.

# Appointment of Tribal Judges for 2013-2014

The Pueblo of Isleta is pleased to announce the appointment of a new Chief Judge and two Associate Judges to the Isleta Tribal Court. Former Lt. Governor Larry R. Lucero has been appointed Chief Judge. Renee Torres, Esq., and Joseph Little have both been appointed as Associate Judges. Their terms will last throughout to the end of 2014 to coincide with the term of the Governor's Administration. We congratulate their appointments and wish them success as judges. We also thank previous Chief Judge Ernest Jaramillo and Associate Judges Robert Medina and Aaron Choneska for their service as judges during the previous

#### Isleta Department of Education, Language Program

The Language Program is in the process of expanding its services. Currently, the Language Program provides community based language classes for all ages, instruction at the Isleta Head Start and the Native American Community Academy. The Language Program also hosts the Summer Language Program and applications shall be ready by Mid April 2013. The Pueblo of Isleta Department of Education Language Program has been working with the Bureau of Indian Education, Education Line Officer, Mr. Casey Sovo to establish a Memorandum of Agreement (MOA) for the Isleta Elementary School (IES). Through the MOA, the Language Program will work collaboratively with the staff at IES to provide Tiwa Language Instruction to Isleta students. This is a process that has been in the works for well over six years. It is with excitement and enthusiasm that we are progressing forward in working closely with the administration and staff of Isleta Elementary School.

The Language Program recently visited Acoma Pueblo Language program to get some ideas and share ideas as well. We will also be visiting Jemez and Cochiti Pueblos in April and Ysleta Del Sur in mid-June. The Interactive website is still in development and will hopefully be available in 2014.

#### Isleta Elementary School

As many of you are aware there are discussions about the Pueblo of Isleta taking over the Isleta Elementary School. The Isleta Elementary School has, in recent years, struggled with making Adequate Yearly Progress (AYP) and decreased enrollment. Through federal rules and regulations, the Pueblo has the right to request administrative control from the Bureau of Indian Education (BIE). However, the Pueblo of Isleta is vested in making the best

decision for our children and has decided to complete a feasibility study before taking action. In conjunction with the feasibility study we are also in the process of requesting technical assistance from the BIE through an Intergovernmental Personnel Act (IPA). Through the IPA, the Pueblo can submit a request to a government agency for an assigned or detailed government employee to assist with specific tasks, such as the feasibility study. On Thursday, March 21, 2013 Tribal Council approved a Resolution approving the feasibility study including: the first step in requesting for an IPA. Once the request for the IPA and Resolution is submitted to BIE, the Pueblo will wait for approval and notification. Once approved by the BIE, there will be a government employee assigned to complete the feasibility study. We anticipate the feasibility study to be complete within two years from the time it begins.

What is a feasibility study? A feasibility study is research developed to provide answers to key questions that guide in the decision making process. This study also analyzes and evaluates the potential of success. We firmly believe that in order to make an educated decision we must obtain and review all data as it pertains to the Isleta Elementary School. Upon completion of the study, a final decision will be made. If the Pueblo of Isleta decides to request for administrative control over Isleta Elementary School, there continues to be an approval process in place with BIE; the Pueblo does not simply assume immediate control over the school. This particular process ranges in length of time as well; it can take two years for Isleta Pueblo to assume administrative control of the Isleta Elementary School.

#### New Mexico State Highway 47 Project

The NM47 Highway Safety Improvement Project is on schedule and will not require any acquisition of Pueblo Land. The base course placement was completed on March 25, 2013. The asphalt paving is tentatively scheduled to start the week of March 25th and will last one week. The week of April 1st, the Contractor will complete any remaining paving and place the final seal coat layer across the full width of the driving lanes. Thereafter, the roadway will be striped and the median will be constructed at the Chical Road (Tribal Road 2) Intersection, on NM47 south of Chical Road. The median work will require a left lane closure in each direction, estimated for Wednesday, April 3rd through Monday, the 8th. We estimate the project completion the week of April 8th. #### **Isleta Cemetery Improvements**

In 2012, the Pueblo of Isleta purchased approximately 2.45 acres that is adjacent to the east side of the existing cemetery for the purpose of expanding the cemetery limits. In the fall of 2012, the Roads Department started cleaning up the area. A separate contractor was hired to remove the large cottonwood trees. Currently the Planning Department is working with the Governor's Office to have engineering plans created for the grading and drainage of the expanded area as well as a design for a new wall that will surround the entire property. The existing chain link fence will be removed and the new wall will be built using Isleta's Lava Block. New walk gates will be installed around the property along with two larger entrances to the north. The plans are currently at the 75% design phase and we hope to start construction this summer. When the project is finished, the landscaping and maintenance will be taken care of by the Parks and Rec Landscaping Division who have already provided great ideas to make the cemetery look nice while paying respect to our departed loved ones.

#### Middle Rio Grande Conservancy District Election

The election, to fill several seats, with the Middle Rio Grande Conservancy District Board of Directors will take place this June 4, 2013. Candidates are currently working diligently to meet their declaration requirements to announce and register their names for candidacy. There are two seats which Isleta voters are eligible to vote for in Bernalillo County (for this election it does not matter which county the Isleta Pueblo voter resides in-Bernalillo/Valencia). The Coalition of the Six Middle Rio Grande Basin Pueblos (Water Coalition) supports Adrian Oglesby (Bernalillo County). For your information and support, Derrick Lente of Sandia and Isleta is also running in Sandoval County. A voter site on the Isleta Reservation has not been determined as yet,

however, we should know this information after April 22, 2013. By voting, you help support not only candidates running for office but help protect the Pueblo of Isleta water rights.

Our Traditional leaders expressed concern about face book postings referencing traditional customs and practices, which were interpreted as demeaning to spiritual beliefs and practices. Our spiritual beliefs and practices are meant to instill in our youth hopes of strengthening our customs and traditions, and doing good for one another for the betterment of future generations to come. Our traditional leaders humbly ask that we protect our spiritual beliefs and hold sacred those values within our hearts.

In closing, we hope that the information provided in this month's newsletter answers any question or concerns that you may have. May you have a very enjoyable month and we ask the creator to protect our people wishing you all good health, happiness and prosperity.

## HUD's Public and Indian Housing Suspends Section 184 Loan Program

"The purpose of this memorandum is to provide lenders, tribes, and tribally designated housing entities with an update on the Fiscal Year (FY) 2013 Federal budget. HUD administers the Section 184 Indian Housing Loan Guarantee Program through the Office of Native American Programs.

All HUD programs are currently operating under a Continuing Resolution (CR) that expires on March 27, 2013. On February 27, 2013, an error in the credit subsidy calculation was discovered and corrected. Based on the revised credit subsidy rate, HUD determined that the budgetary resources provided for the Section 184 Program under the CR had been exhausted. HUD is therefore suspending issuance of firm commitments for Section 184 program borrowers and lenders who will now need to work towards finding other financing options.

HUD encourages you to share this letter with your tribal government principals and members. Additionally, HUD will make every effort to share additional information as it becomes available, and will be ready to offer assistance and guidance to all Section 184 stakeholders."

Comment by Eric Schmeider (NM Tribal Homeownership Coalition): This is bad news. Probably no new funding until Congress passes and the President signs a Continuing Resolution covering the rest of the Fiscal Year. This should occur by March 27th at the latest. But 184 funding could be limited and under-funded for the Fiscal Year and beyond.

## NM Indian Livestock Days

Indian Livestock Days began in the 1970's and was initially called All Indian Livestock School. It was discontinued in 1978 and reestablished in 1985, at the request of tribal livestock producers. Originally the event was held in April and hosted on the main NMSU campus in Las Cruces. In 1996, the location was moved around the four-corners area to make it easier for clientele to attend the event. This event has grown from approximately 65 attendees in 1996, to 230 attendees in 2012. New Mexico Indian Livestock Days is now an annual event held in May, conducted by NMSU Cooperative Extension Service.

What makes New Mexico Indian Livestock Days unique? The people in general. Tribal members raising livestock face many challenges-- not enough land, not enough feed on the land they have, and not enough water, just to name a few. One of their main challenges is to remain true to their ancestors and their religious beliefs. With that being said, it does not hold them back, it just makes more of a challenging experience, and it means much more to them than the average cattleman.

The program is a grassroots program driven by clientele needs and interest. The planning committee is made up of Extension Agents which service the Native American population, tribal members of the various tribes in New Mexico, and NMSU CES State Specialists.

# TIWA LENDING SERVICES

**Tiwa Lending Services** is a Native Community Development Financial Institution (CDFI) that was incorporated January 6, 2011. It is a non-profit entity whose mission is to promote the economic growth of the Isleta Pueblo community by creating homeownership and small business opportunities for the Isleta community. Tiwa Lending Services currently operates out of the Isleta Pueblo Housing Authority (IPHA) Offices located at Tribal Road 61 #3.

Tiwa Lending Services took over the Isleta Home Loan Program effective March 2012. Services' goals are to seek additional funding from federal and state governments, private foundations and various organizations for its lending and financial services activities.

Tiwa Lending Services (TLS) is expanding its target market, loan products and development services, and would like to update its market study of 2012 by conducting another round of surveys that would supplement the current market study. William Guevara from First Nations Oweesta Corporation will be in town to distribute and collect surveys onsite at the Child Abuse Awareness Parade and BBQ held at the Recreation Center. All participants who complete a survey form will be entered into a drawing to win a gas card and the drawing will be held at the end of the day. Participants need not be present to win, but will be notified immediately and recognized in the upcoming newsletter for their participation. TLS in the coming weeks may ask employees working at some of the Tribal Enterprises to complete a survey also.

#### Pueblo of Isleta Veterans' Association Capital Outlay Funds

The 2013 NM Legislative session is over, and we're happy to report that the legislators have been good to the Pueblo of Isleta Veterans Association. The Association was awarded \$188,000 in capital outlay funds. Most of the funds will be used to set up the old MIS module at the Richard "Dickie" Baker Field in Los Charcos. This will include the installation of a waste water disposal system, utility hook ups, driveway construction and what ever else that these funds will possibly pay for. The MIS module was donated to the Association by the Tribal Administration.

If you haven't noticed, the Tribal Enterprise has begun tractor work on the south end of the Baker Field, getting ready for spring planting. This is a part of the future plans, which eventually will someday be the site of the Richard Baker Memorial Veterans' Center. The completion of the Center is still a few years down the road. For now the MIS module which will be incorporated into the master plan will be the beginning of the permanent site.

The next meeting of the Veterans' Association will be on 17 April 2013. Since the heater at the old Headstart stopped working, and the weather has not changed to warm, we've been meeting at the Natural Resources building conference room, thanks to Capt. Steve Abeita (USA). Supposedly, our next meeting should be wherever place Capt. Steve designates. Check the weather... if all is warm, we may meet at our old Headstart site.

### **Animal Control Report:**

We will be having our Spring Rabies Shot Clinic on April 17, 2013. From 9am-11:30am we plan on being set up at the Health Center, and at the old courthouse in the plaza from 1pm-3pm. Your pet must be at least 3 months old to receive the rabies vaccine. All pets must also be on a leash.

Also, if your dog or cat goes missing, please contact Animal Control right away. When we do pick up an animal off the street, we do our best to identify the animal and where it might have come from. However, the majority of animals we pick up do not have tags. If we cannot identify it, it will be transported to Valencia County Animal Shelter. If we are able to identify it and nobody is home, we will leave a note at that residence. On the note, we will advise them that their animal has been picked up, that we attempted to return it, but unfortunately nobody was home and it was transported to the shelter.

Since the beginning of the year, Animal Control has transported well over 100 animals to Valencia County Animal Shelter. Only 5% of the animals that are taken to the shelter are reclaimed by their owners. About 13% of the animals are adopted by a new family. Approximately 33% of the animals are sent to various "rescue" organizations and about 49% are euthanized at the shelter's discretion. Puppies and kittens make up 33% of the euthanized animals. That is why it is important to call Animal Control immediately, if your pet has gone missing.

## Final Legislative Update on HB 376 – Native Americans in Medicaid Managed Care

HB 376, also known as the *Medicaid Bill*, stalled in committee and did not pass the Senate. As the dust settles from this year's legislative session, it remains unclear what the impacts will be for citizens of New Mexico's tribes who are currently enrolled in Medicaid.

As we reported in the last newsletter, HB 376 passed successfully through the House at the end of February.

When it was introduced in the Senate, it was assigned to three committees – Senate Indian Affairs, Senate Judiciary and Senate Finance. This is widely regarded as the "kiss of death" among legislative circles because bills very rarely make to the floor for a vote going through three committees. It passed the first two, unanimously, but stalled in the Senate Finance Committee.

The chairman there, John Arthur Smith, refused to hear the bill or to send it to the Senate Floor for a final vote. Tribal leaders and non-profit advocacy groups made a last ditch effort by calling or sending letters to the senator's office, but to no avail. The session ended on March 16 without a vote.

Isleta's senator, Michael Sanchez, sits on the Senate Judiciary Committee and voted in favor of the bill.

Tribal leaders and tribal health employees throughout the state, and here in Isleta, are trying to figure out what this all means for tribal members on Medicaid and where they will fit into the state's newly introduced Centennial Care program.

Currently, there is a 90-day one-time managed care disenrollment window. The bill would have reduced that to a 30-day window.

The issue is sure to be a topic of discussion at this year's State Tribal Summit to be held June 20-21.

Dear Parents of Seniors,

Graduation is quickly approaching. Congratulations will be in order, but first, all seniors need to make sure they have met all graduation requirements.

If students are working on E2020 Credit Recovery courses, those courses must be completed by Wednesday, May 8, 2013 at 3:00pm (NO Exceptions). E2020 Credit Recovery is available every day after school in Room 405 from 2:30pm until 4:30pm, and late arrival Wednesday mornings from 7:25am until 8:25am. Unmet course requirements will prevent students from participating in the graduation ceremony. Graduation will be held at the UNM Pit on Saturday, May 18, 2013 at 9:00am. Students must meet at the UNM Pit by 8:00am.

Because of the Lottery Scholarship, seniors are urged to apply to at least one New Mexico College. Kim Griego, our Registrar, will send transcripts and test scores to colleges upon student request. Final transcript requests will be made during Senior Check-Out on Friday, May 10, 2013. Senior Check-Out will run from 8:00am until 11:00am.

The New Mexico Legislative Lottery Scholarship is available to all seniors who begin attending a state college during the fall semester after graduating high school. To keep the New Mexico Legislative Lottery Scholarship, incoming freshmen must pass 12 hours of college credit their fall semester with a 2.5 semester GPA. Most New Mexico state colleges offer a Bridge Scholarship to help incoming freshmen pay their fall tuition costs. After your student has submitted the FAFSA, contact the financial aid offices of the colleges of your choice to make sure that everything is in order.

Additionally, college athletes need to register with the NCAA Clearing House. Males over the age of 18 need to register with Selective Service in order to be eligible to receive financial aid. This can be done online.

You will find a great deal of information on college admissions and scholarship opportunities.


# Parks & Recreation


#### **Local Senior Games**

Because we hosted the training we were able to have four of our employees get certified at no cost to us which would have been about \$845.00 per student. Incidentally, we had about 25 people from throughout the country not only take this training but also used our Hardrock Hotel and Casino as their lodging. Many of those who were here had nothing but great things to say about our facilities and the hospitality.

#### Park Management

Beginning immediately, we the Parks & Recreation Department have taken over the maintenance of most ground maintenance in our public buildings here at the Pueblo of Isleta. #### **NEWS:**

As most of you noticed the weather is starting to heat up, so with that said, we would like to remind all you parents, guardians, aunts, uncles, older brother/ sisters, and baby sitters NOT to leave your children unattended in your vehicles. 
#### **UPCOMING PROGRAMS:**





# Car Seat Clinics

# Have you ever been to a Car Seat Clinic? What is it? Why do we have them?

The purpose of a Car Seat Clinic, also known as a Child Safety Seat Check, is to educate parents, grandparents and guardians on properly installing and the proper use of their child/grandchild's car seat. If the car seat is out of date, recalled or not appropriate for the child, there is a possibility that the car seat may be replaced if there are seats available, but a car seat clinic does not just give car seats away. There are guidelines we must go by and we are not allowed to give away car seats freely. Our Child Passenger Safety Technicians (Frances Anchondo-869-4482 and Stephanie Barela-869-4479) are available by appointment year round. Each appointment can take up to an hour. Your child and the car seat MUST be present in order complete the car seat check. During each Car Seat Check, we will **Inspect – Educate**:

- $\ensuremath{\bullet}$  review the suitability of the child car seat
- ensure the harness is properly fitting with the child
- demonstrate the correct installation
- discuss injury prevention
- · answer any questions

# Why is it important to use Child Safety Seats for your child?

Motor vehicle injuries are the leading cause of death among children in the United States, but many of these deaths can be prevented. Placing children in age- and size-appropriate car seats and booster seats reduces serious and fatal injuries by more than half, according to the Centers of Disease Control (www.CDC. com). In the United States during 2009, 1,314 children ages 14 years and younger died as occupants in motor vehicle crashes, and approximately 179,000 were injured. One CDC study found that in one year, more than 618,000 children ages 0-12 rode in vehicles without the use of a child safety seat, booster seat or a seat belt at least some of the time. Not only are parents not insuring the child to be in a safety seat, but if they do put them in a safety seat, it is usually used incorrectly. One study found that 72% of nearly 3,500 observed car and booster seats were misused in a way that could be expected to increase a child's risk of injury during a crash. Not only do we see national studies that show a high number of car seats being incorrectly installed, but every year at Isleta Health Center's Car Seat Clinics, we see many car seats incorrectly installed. In February's Car Seat Clinic in Isleta, there were 12 car seats inspected, 9 of which were incorrectly used, which is a 75% misuse rate. This shows how important it is to get your child's car seat checked, to insure the safety of it. Schedule an appointment with us, to insure that your child is safe in their car seat.

# PREVENT INJURY— BUCKLE UP!!

Do you put your seatbelt on EVERY TIME you get into the car? Well, as the 4th grade students learned, it's ONE OF THE MOST IMPORTANT things you can do to PREVENT INJURY!!! After learning about seatbelt safety, the Isleta Elementary School 4th graders put on their first Observational Seatbelt Survey on November 9th, 2012 and Mrs. King's 4th grade class just had the 2nd seatbelt survey for the school year on March 22, 2013. Both surveys took place in front of the clinic. The students kept track of how many individuals were wearing their seatbelt. The 4th graders had a great time promoting safety by educating those that passed about the importance of wearing their seatbelts. They held up signs promoting seatbelt use and noticed that if they inform people about the importance of wearing their seatbelt, they can make a difference and people will be safer.

The results they found from observing the vehicles are interesting. Isleta is not being as safe as we have been in the The number of people wearing their seatbelts is down in some areas and up in others. The December 2012 results SHOW US THAT MANY DRIVERS ARE being safe and wearing their seatbelt, however, when it comes to the passengers in the vehicle, they are not being as safe. Ninety-four percent (94%) of the drivers wore their seatbelt (Dec 2012 results), compared to only 74% of the drivers in Spring 2011, which is great that it went up, but then the results from the most recent survey in March went down, with only 82% if the drivers wearing their seatbelt. The most concerning part of the results show that only 64% of the passengers wore their seatbelt, compared to 67% in Spring 2012 and a saddening 22% in Spring of 2011.

Looking at these results can hopefully open our eyes to how unsafe we are being. Seatbelts reduce serious crash-related injuries and death by about 50% (www. cdc.gov). Motor vehicle crashes are the #1 cause of death for those 5 years old to 34 and wearing your seatbelt can help reduce this risk, so it is VERY important that EVERYONE in the vehicle wear a







- seatbelt, not just the driver, but also the passengers!! Here are some tips:
  - Use seatbelts on every trip, no matter the distance.
  - Make sure children are properly buckled up in a seatbelt, booster seat or car seat. Contact Isleta Health Center Car Seat Technicians, Stephanie 869-4479 and Frances-869-4482, to get your car seat checked and make sure your child is in the appropriate car seat.
  - Have all children 12 and under in the back seat.
  - Never seat a child in front of an air bag.
  - Place children in the middle of the back seat when possible, because it is the safest spot.

Child safety seats reduce the risk of death in passenger cars by 71% for infants, and by 54% for toddlers ages 1 to 4 years.

- •Know the stages:
  - Birth through Age 2 Rear-facing child safety seat. For the best possible protection, infants and children should be kept in a rear-facing child safety seat, in the back seat buckled with the seat's harness, until they reach the upper weight or height limits of their particular seat. The weight and height limits on rear-facing child safety seats can accommodate most children through age 2, check the seat's owner's manual for details.
  - Between Ages 2-4/Until 40 lbs Forward-facing child safety seat. When children outgrow their rear-facing seats (the weight and height limits on rear-facing car seats can accommodate most children through age 2) they should ride in forward-facing child safety seats, in the back seat buckled with the seat's harness, until they reach the upper weight or height limit of their particular seat (usually around age 4 and 40 pounds; many newer seats have higher weight limits-check the seat's owner's manual for details).
  - Between Ages 4-8 OR Until 4'9" Tall Booster seat. Once children outgrow their forward-facing seats (by reaching the upper height and weight limits of their seat), they should ride in belt positioning booster seats. Remember to keep children in the back seat for the best possible protection.
  - After Age 8 AND/OR 4'9" Tall Seat belts. Children should use booster seats until adult seat belts fit them properly. Seat belts fit properly when the lap belt lays across the upper thighs (not the stomach) and the shoulder belt fits across the chest (not the neck). When adult seat belts fit children properly they can use the adult seat belts without booster seats. For the best possible protection keep children in the back seat and use lap-and-shoulder belts.
- All children younger than 13 years should ride in the back seat. Airbags can kill young children riding in the front seat. Never place a rear-facing car seat in the front seat or in front of an air bag.
- Place children in the middle of the back seat when possible, because it is the safest spot in the vehicle.
