## **ORDER GRANTING A TEMPORARY CIVIL INJUNCTION**

**THIS MATTER** came before the Court on Petitioner's motion containing allegations of harassment and/or interference and concerning the above named person(s), and the Court **HEREBY FINDS:** 

Isleta Tribal Court has jurisdiction over this matter as a civil controversy with this Court exercising its civil jurisdiction. Pursuant to the Isleta Law and Order Code §30-01-09 civil jurisdiction of the Isleta Tribal Court shall extend to all civil actions in which the cause of action arose in whole or in part, on Pueblo Lands.

The Court finds probable cause to believe there is a need to assure that the Petitioner shall be free from harassment or interference from Respondent.

**IT IS THEREFORE ORDERED** that an immediate Temporary Civil Injunction is being issued by this Court and:

- □ The parties shall not have direct or indirect personal contact with one another in any manner whatsoever.
- □ Neither party shall go within one-hundred (100) yards of the other party, including but not limited to, each other's current place of residence and employment.
- Neither party shall add debt to, sell, remove, hide, destroy, or damage any property owned by the other party. This restriction includes tampering with electrical or other utility lines and corresponding services.
- □ The Respondent(s) shall not have any personal or public contact with the Petitioner.
- □ In addition, the Respondent(s) shall:\_\_\_\_\_
