Pueblo of Isleta Tribal Court Bond Schedule

The Indian Civil Rights Acts requires that no excessive bail be required. 25 USC1302 (a) 7 as adopted by the Pueblo of Isleta Constitution Art. III 1(g) and Criminal Procedures 3.9-3.13 applies to this law. The following bail schedule is effective and the previous bail (bond) schedule is hereby rescinded. No surety bonds will be accepted nor is authorized. Bail will be posted at the Detention Facility where the Defendant is incarcerated by a money order made payable to the Pueblo of Isleta. The court may raise or lower the bail amount to assure the defendant does not pose a danger to the community, or is not a flight risk. The charge with the highest amount of bail shall determine the bail amount.
