I would like to thank our tribal members who attended our quarterly Community meeting that was held on Saturday, October 21, 2023 at Isleta Resort and Casino. I have taken your feedback into consideration and I will continue to work towards the success of our Pueblo, thank you for your continued support.

We would like to thank our Recreation department and staff for hosting another successful Halloween Carnival for our community. It is nice to see all the departments participating from preparations meetings to the final event. We thank the community for coming out, enjoying the festivity along with seeing all the awesome costumes and children having a good time.

We would like to invite all tribal members to attend *The Road to Healing*. *The Road to Healing* serves as a tour across the country to provide survivors of the Federal Indian boarding school system and their descendants an opportunity to share experiences. NOVEMBER 2023 PER CAPITA DISTRIBUTION AUTHORIZATION

At a duly called meeting of the Tribal Council of the Pueblo of Isleta, held on October 20, 2023, the following resolution was passed:

WHEREAS, the Pueblo of Isleta (the "Pueblo") is a federally recognized Indian Tribe organized pursuant to its Constitution adopted in accordance with the Indian Reorganization Act and with the inherent powers of self-government;

WHEREAS, the Pueblo is governed by a Governor and Tribal Council made up of elected representatives who act in accordance with the Pueblo of Isleta Tribal Constitution ("Constitution");

WHEREAS, Article V, Section 2(i) of the Constitution authorizes the Isleta Tribal Council to "appropriate such funds as necessary for the health, safety, and general welfare of the pueblo, for other public purposes and per capita payments to members of the pueblo;"

WHEREAS, Article V, Section 2(l) of the Pueblo of Isleta Constitution authorizes the Isleta Tribal Council to "otherwise manage and control the lands and resources of the pueblo for the best interest of the pueblo;"

WHEREAS, the Tribal Council finds that it is in the best interests of the Pueblo of Isleta to authorize a November 2023 per capita distribution to all enrolled Tribal Members, regardless of their place of residency;

WHEREAS, the distribution under this Resolution shall be made from the Proceeds of Labor Account held at the Office of Trust Funds Management to fund a per capita distribution which will total approximately **\$3,756,750.00**;

WHEREAS, the Tribal Council has determined that it is in the best interests of the health, safety, and general welfare of the Pueblo to issue such distribution pursuant to the criteria described herein;

NOW THEREFORE BE IT RESOLVED, the Tribal Council hereby authorizes the November 2023 Per Capita distribution as follows:

1. Definitions:

- a. "Tribal Member" shall mean a person enrolled with the Pueblo of Isleta as a Tribal Member and approved by Tribal Council or Tribal Enrollment Committee as of October 17, 2023.

2. Criteria for Distribution:

- a. A Tribal Member must be an enrolled Tribal Member as of October 17, 2023 to be eligible for the November 2023 Per Capita Distribution.
- b. All eligible Tribal Members will receive a per capita distribution \$750 to be distributed by the Treasurer's Office, as described below in "Distribution Procedures."

3. Distribution Procedures:

- a. Distributions for in-state Tribal Members will be made by check and should be picked up in-person, unless the Tribal Member provides an original, notarized letter requesting their distribution to be sent via certified mail pursuant to Section 4(b).
- b. Except for those qualifying for the distribution procedures described under Section 4 below, all Tribal Members must pick up their checks in-person on Wednesday, November 29, 2023, from noon to 7:00pm and Thursday November 30, from 9:00am to 4:00pm at the Isleta Main Recreation Center. A Tribal ID or valid driver's license must be presented to receive the distribution.
- c. Alternatively, Tribal Members may pick up checks from the Treasurer's Office Mondays through Fridays during normal business hours, 8:00am to 4:30pm from December 1, 2023 through March 22, 2024.
- d. All distributions hereunder must be deposited or cashed by a bank by March 29, 2024. Any checks not cashed prior to that date shall be null and void.

4. Distribution Procedures for Those Unable to Pick up a Distribution Check in Person

- a. A Tribal Member who is out-of-state or otherwise unable to pick up their check in person at the Recreation Center during the designated dates or from the Treasurer's Office during business hours may provide an original, notarized letter designating

another individual to pick up their distribution check on the unavailable Tribal Member's behalf.

- b. A Tribal Member who is out-of-state or otherwise unable to pick up their check in person may also provide an original, notarized letter to the Treasurer's Office requesting that their distribution be sent via certified mail. The notarized letter must include the address to which the distribution check should be sent. A Tribal Member requesting their distribution be sent via certified mail must request that the Treasurer's Office do so by March 1, 2024. Any checks returned to the Treasurer as undeliverable or otherwise returned shall be void, no longer available, and shall not be reissued to the intended recipient

- c. All distributions, including those sent via certified mail, will be null and void if they are not cashed and cleared by a bank on March 29, 2024.

5. Distribution Procedures for Minors

- a. November 2023 Per Capita Distribution checks will be issued to minors directly and shall not be routed to their Bureau of Indian Affairs Individual Indian Money account.
- b. Per capita distribution checks for Tribal Members under the age of 18 shall be picked up by the minor's parent, or legal guardian, or custodian, in accordance with the records of the Isleta Tribal Court and Census/Enrollment Department. The Treasurer's Office shall not issue a distribution check to a minor's parent if the parent is not a custodial parent or legal guardian. If there is no custody documentation on file with either Isleta Tribal Court or the Census/Enrollment Department, the Treasurer's Office will provide the distribution check to either parent or legal guardian of record.
- c. If a minor Tribal Member is a ward of the Isleta Tribal Court, Isleta Social Services shall pick up the distribution check on the minor child's behalf.

6. Withholding of Distribution:

The November 2023 Per Capita Distribution shall not be subject to any withholdings, including but not limited to garnishments, fees, restitution, and child support.

7. Funding Sources:

Approximately **\$3,756,750.00** may be withdrawn from the Pueblo of Isleta Proceeds of Labor Account to fund the November 2023 Per Capita Distribution. The Distribution is non-taxable.

BE IT FURTHER RESOLVED, that the Tribal Council authorizes the Treasurer to mail all per capita distributions issued pursuant to this Resolution to Tribal Members and appropriates an amount not to exceed \$6,200.00 to the Treasury budget to send the distributions via certified mail; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon adoption by the Tribal Council and shall remain in effect until otherwise superseded or repealed by Tribal law.

AMENDING THE PUEBLO OF ISLETA TRIBAL LAW AND ORDER CODE TO
INCLUDE CRIMINAL ENFORCEMENT OF THE RESIDENCY ORDINANCE, AS
AMENDED HEREIN

At a duly called meeting of the Tribal Council of the Pueblo of Isleta, held on October 3, 2023 the following Resolution was passed:

WHEREAS, the Pueblo of Isleta is a federally recognized Indian tribe with a written Constitution adopted pursuant to the Indian Reorganization Act and with the inherent powers of self-government;

WHEREAS, Article V, Section 2(e) of the Pueblo of Isleta Constitution authorizes the Tribal Council to "enact ordinances to protect the peace, safety, property, health, and general welfare of the members of the Pueblo of Isleta;"

WHEREAS, Article V, Section 2(f), of the Constitution for the Pueblo of Isleta authorizes the Tribal Council to "manage and control the lands and resources of the pueblo for the best interest of the pueblo;"

WHEREAS, governing the residence of members and non-members is an important aspect of protecting the customs and traditions of the Pueblo;

WHEREAS, the Pueblo has and continues to govern the residence of members and non-members who reside within Pueblo of Isleta lands, under its inherent authority of self-government and pursuant to customs and traditions;

WHEREAS, Tribal Council adopted the Pueblo of Isleta Residency Ordinance on December 20, 2010, and amended it on July 26, 2011; and

WHEREAS, the Tribal Council finds it to be in the best interest of the Pueblo to approve the proposed amendments to the Tribal Law and Order Code, as amended herein.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Council hereby approves the amendments to the Tribal Law and Order Code as set forth herein, and

WHEREAS, the Tribal Council finds it to be in the best interest of the Pueblo to approve the proposed amendments to the Tribal Law and Order Code, as amended herein.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Council hereby approves the amendments to the Tribal Law and Order Code as set forth herein, and

BE IT FURTHER RESOLVED, that the Tribal Council hereby directs the Legal Department to, within 90 days of adoption of this Resolution, codify this Resolution into Title 30 of the Tribal Law and Order Code, as follows, applying changes to numbering, titling, and identification language as necessary, and shall provide notice of the same to the Tribal Council, the Isleta Tribal Court, the Governor, the Treasurer, and MIS:

30-12-22 Unauthorized Harboring of a Non-Tribal Member

A. As used in this section:

(1) "non-tribal member" means an Indian, who is not a recognized tribal member of the Pueblo of Isleta or a Non-Indian person.

(2) "residency" means the act of dwelling on Pueblo of Isleta lands for a period of five (5) consecutive days or longer, two (2) or more consecutive weekends, or seven (7) or more intermittent days in a thirty-day period.

(3) "tribal member" means an Indian, who is a recognized tribal member of the Pueblo of Isleta.

B. A Pueblo of Isleta tribal member who allows a non-tribal member to reside on a property within the Pueblo of Isleta's exterior boundaries after being subject to a notice or order prohibiting that non-tribal member from residing on the Pueblo of Isleta is guilty of a Class B Misdemeanor. A tribal member previously convicted under this section shall be guilty of a Class A Misdemeanor.

30-12-23 Unauthorized Entry or Residency

A. As used in this section:

(1) "non-tribal member" means an Indian, who is not a recognized tribal member of a Pueblo of Isleta.

(2) "residency" means the act of dwelling on Pueblo of Isleta lands for a period of five (5) consecutive days or longer, two (2) or more consecutive weekends, or seven (7) or more intermittent days in a thirty-day period.

B. A non-tribal member shall not enter the Pueblo of Isleta's exterior boundaries when notice of or a barrier against entry has been erected, posted or otherwise reasonably communicated or a consent to enter has been withdrawn.

C. A non-tribal member shall not reside within the Pueblo of Isleta's exterior boundaries without prior authorization from the Pueblo of Isleta.

D. Any non-tribal member found guilty of unauthorized entry or residency is guilty of a Class D Misdemeanor. A non-tribal member previously convicted under this section shall be guilty of a Class C Misdemeanor.

BE IT FURTHER RESOLVED that this Resolution shall go into effect immediately upon adoption by the Tribal Council and shall remain in effect until otherwise superseded or repealed by Tribal Council.

People who wish to submit an article or flyer are responsible for generating their own article or flyer. Should you need help, please call the Library at 505.869.9808 and set up a date and time to sit down with a Library staff member who will help you throughout the process. The Library will NOT accept notes dropped off at the Library or information over the phone to generate your article.

PROBATES need to be published in the Newsletter for two consecutive months. Probates are considered court documents, therefore, all submitters must provide: 1) Name of Deceased, 2) Date of Deceased 3) Court Case # and 4) Date of Court Date. A Probate form can be found on the Newsletter Archive page at <http://www.isletapueblo.com/newsletters.html>.

CLASSIFIED ADS: The new administration has requested that the Newsletter start a Classified Ad section for Tribal members selling land, houses, mobile homes, vehicles, and farm equipment. Leasing of houses and mobile homes will be accepted. Smaller items which can be sold at the local flea markets or weekly yard sales will NOT be accepted.

Currently, this service is FREE to Tribal members. Land, houses, and mobile homes must be within the reservation boundaries. Ads must meet the 160 character limit. Ads that exceed the 160 characters will NOT be submitted into the Newsletter. A single picture June be submitted with the ad. Submitters of classified ads are responsible for generating their own ads as this is a FREE service.

As a reminder, Tribal business owners may submit a small flyer at no charge. Like the classified ads, business owners are responsible for generating their own flyers as this is a FREE service.

Classified ads and business flyers will be posted no more than two consecutive months. In the event where the Newsletter may exceed the 24-page limit, classified ads and business flyers will be “bumped” for newsletter articles. Again, this is a FREE service for Tribal members.

The Isleta Newsletter is owned and operated by the Pueblo of Isleta. Therefore, the Governor of the Pueblo of Isleta has the final say of all articles and contents within the Isleta Newsletter.

Isleta Tribal Court is offering two days of amnesty to clear up any warrants you may have.

Isleta Tribal Court currently has 72 active warrants, some cases date back to 2015. If you have a warrant, we are offering a day of amnesty for you to come be heard, and get your warrant resolved.

WHEN: Friday November 3, 2023, and Friday November 17, 2023.

TIME: 9:00am – 3:30pm

LOCATION: Isleta Tribal Court

HOW: Come to the Tribal Court on the above-mentioned days at any time between 9:00am -3:30pm, and the court will immediately hear your case to resolve your warrant. You will not be arrested upon first sight. You will be given an opportunity to be heard and your record reviewed.

Affordable Connectivity Program

The Affordable Connectivity Program is an FCC benefit program that helps ensure that households can afford the broadband they need for work, school, healthcare and more.

The benefit provides a discount of up to \$30 per month toward internet service for eligible households and up to \$75 per month for households on qualifying Tribal lands. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price.


The Affordable Connectivity Program is limited to one monthly service discount and one device discount per household.

Who Is Eligible for the Affordable Connectivity Program?

A household is eligible for the Affordable Connectivity Program if the household income is at or below 200% of the Federal Poverty Guidelines, or if a member of the household meets at least one of the criteria below:

- ☐ Received a Federal Pell Grant during the current award year;
- ☐ Meets the eligibility criteria for a participating provider's existing low-income internet program;
- ☐ Participates in one of these assistance programs:
 - Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture (USDA) Community Eligibility Provision schools.
 - SNAP
 - Medicaid
 - Federal Housing Assistance, including:
 - Housing Choice Voucher (HCV) Program (Section 8 Vouchers)
 - Project-Based Rental Assistance (PBRA)/ Section 202/ Section 811
 - Public Housing
 - Affordable Housing Programs for American Indians, Alaska Natives or Native Hawaiians
 - Supplemental Security Income (SSI)
 - WIC
 - Veterans Pension or Survivor Benefits
 - or Lifeline;
- ☐ Participates in one of these assistance programs and lives on Qualifying Tribal lands:
 - Bureau of Indian Affairs General Assistance
 - Tribal TANF
 - Food Distribution Program on Indian Reservations
 - Tribal Head Start (income based)

Facilitating the assessment, design, and launch of the community-led "EJ Air" monitoring network, which will record and analyze air quality data in the Mountain View Neighborhood, Valle de Oro NWR, and the larger South Valley area. The data collected by the EJ Air project will help identify and assess public health and safety risks from pollution, and paint a picture of the environmental injustices faced by local communities. Ultimately, the project will seek to build solutions to mitigate and prevent further harms.

Responsibilities:

- Coordinate and Support General operations of EJ Air Network
- Work with the EJ Air Steering Committee and EJ Air Personnel in planning and implementing a community-led air monitoring network and program.
- Facilitating meetings for the collaborative assessment, design, and launch of the community-led "EJ Air" monitoring network.
- Co-Coordinate EJ Air Network community-based design, network plan, and deployment with Steering Committee, network partners, and sub-contractors.

PUBLIC WORKS ON-CALL PROCEDURE

Due to a recent agreement between the Housing Department and Public Works Department Director, Public Works will handle all residential and utility issues during normal business hours, after hours, on call and emergency calls to homeowners whose homes are non IPHA owned (homeowners who no longer make payments on the home). After hour calls by Tribal Members received through Isleta Dispatch for issues related to electrical hazards, water leaks, sewage issues, gas leaks, heating, ETC., dispatch will contact Public Works on-call staff.

All calls must be safety related or a true emergency. An emergency situation is one in which damage may occur to the home or is a risk to the health and safety of the homeowner or the Pueblo of Isleta.

Tribal Members need to call Isleta Dispatch (505-869-3030) unless it is an emergency such as a potential gas leak. The Dispatcher will ask for basic information and contact the staff member on call for Public Works. The Public Works employee will call the Tribal Member and ask questions related to the issue. The employee may ask to video call with you so they can visualize the issue you are experiencing. The employee will ask questions to ascertain if it is an actual emergency situation or if the issue can be taken care of the next business day.

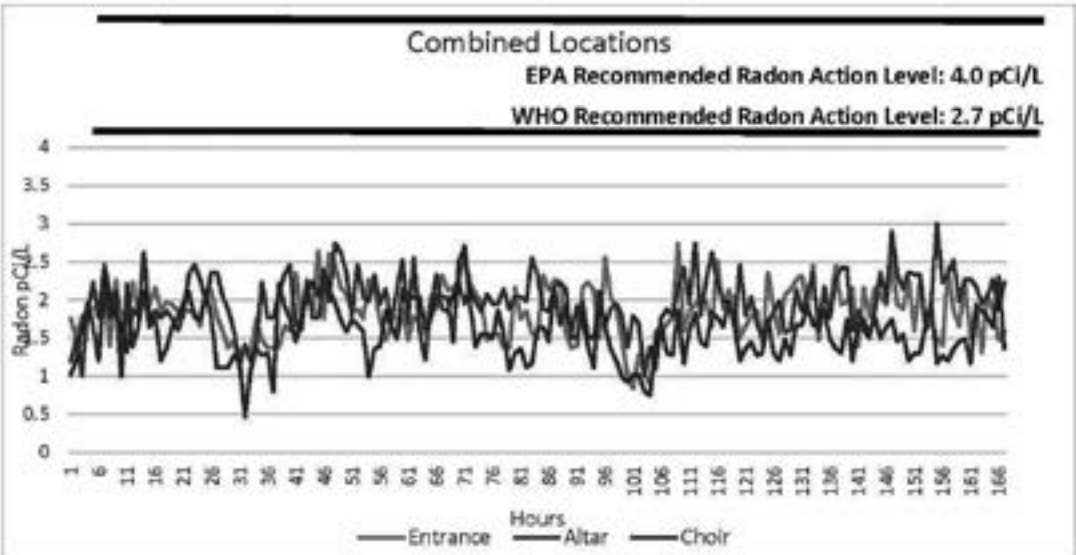
Elders, handicapped, veterans and single parent families is our 1st priority.

Here are some example situations of what Public Works will and will not respond to:

- The homeowner notices an odor of gas in the home contact Dispatch immediately and Fire Department will be notified. Be sure to advise Dispatch of this situation, leave your home and wait for emergency responders. **This is an emergency and Public Works staff will respond as quickly as they can.**
- A water heater is leaking inside the home, causing damage to the flooring. Homeowner is not able to shut off the water supply – this is an emergency and **Public Works staff will respond as quickly as they can.**
- There is only one toilet in the home and it is not working. Since there is only the one toilet fixture in the home, **Public Works staff will respond.** If a second toilet was available for use, **Public Works would not respond until the next business day unless it is a handicap restroom.**
- Furnace or heater is not working and it's the only heat source for the home: Very cold temperatures expected and the potential for pipes to freeze is a concern, **Public Works will respond. Temperatures overnight are expected to be in the high 40s – Public Works will respond the next business day.**
- Sewage is backing up into the home, **Public Works staff will respond.**
- If the kitchen sink or bathtub/shower is the only fixture in the home not draining, **Public Works will respond the next business day.**

Recent radon monitoring conducted in late mid-September 2023 inside the St. Augustine Church continues to show radon levels well below the EPA recommended radon action level of 4.0 pCi/L, with averages also below the WHO recommended radon action level of 2.7 pCi/L. Each radon monitor was set out for a total of 7 days which continuously collected radon levels as seen in the above line chart. As a reminder, the average radon levels used to be around 19.5 pCi/L inside the Church. Now, average levels are around 1.8 pCi/L and have remained low since appropriate changes were made to allow high air flow inside the building. The Pueblo of Isleta Environment Department will continue to monitor radon levels periodically to ensure the HVAC system is working properly to keep radon levels low.

Monthly surface water quality results

Water quality results from the laboratory for the month of September 2023 were not available on time to meet the deadline for publication in the November Newsletter. The Pueblo’s water quality data table is published each water year, October 1 through September 30th the following year.

Public Comment Opportunity

Pueblo of Isleta Environment Department is seeking comment on termination of the U.S. Environmental Protection Agency’s (EPA) consent order for the former Wall Colmonoy Corporation hazardous waste site.

As of June 2023, there have been at least four semiannual sample results with concentrations of total chromium below the Federal maximum contaminant level in all of the groundwater monitoring wells on the former Wall Colmonoy site. The maximum contaminant level for total chromium is 0.1 milligram per liter of water. EPA Region 6 Hazardous Waste Enforcement staff consider the chromium contamination in groundwater beneath the former Wall Colmonoy site to have become naturally attenuated.

At an appropriate time in the future, the Pueblo will seek federal grant funding, other resources, and expertise to begin the planning process for redevelopment of the Wall Colmonoy site.

Public comments are one of many ways Isleta community members can support informed decision-making.

COLD TEMPERATURES ARE COMING, ARE YOU READY?

It's that time of year to get ready for "Old man Winter". Prepare your home now for cold temperatures that can freeze your water or sewer pipes. Heat tape, insulation, skirting, heat lamps or even a light bulb can help prevent freezing temperatures from causing damage to your water/sewer lines.

If you have a swamp cooler, be sure to disconnect the water supply line to the swamp cooler and allow the line to completely drain. Turn off any frost frees or spigots that supplied the water to the cooler, remove garden hoses and insulate the frost free/spigot to help prevent freezing.

If your water or sewer lines do freeze, damage to the pipe may occur. Lines may crack/break creating leaks. There is no quick fix for broken lines. Public Works does not know where every water service shut-off is at. If a water line freezes and breaks, it will take Public Works employees time to locate the main water shut-off; especially if there is snow or ice on the ground. Residents are encouraged to locate their water shut-off devices and have some type of marker placed by the shut-off so the water can be shut-off quickly in an emergency.

Homeowners should look for a shut-off valve inside the home that will isolate interior piping in an emergency. Knowing where the shut-off is located, knowing how to turn the water off, and verifying the valve works will save time and damage in an emergency.

TRUMAN D. PICARD (1946-1986)

To honor Truman D. Picard the ITC established a scholarship program in his name. Truman served on the ITC Board of Directors from 1982 to 1985. While working for the Bureau of Indian Affairs, Colville Agency, in presales he attended the Forest Engineering Institute at Oregon State University becoming one of the first people from the agency to complete this program. In 1977, Truman transferred to the Colville Tribal Forestry organization taking a position as Supervisory Forest Technician in charge of woods operations. Later he was promoted to Assistant Supervisor of Forestry Operations. Because of his drive and determination to complete his education Truman returned to Oregon State University earning a Bachelor of Science Degree in Forest Management. Upon his return from college, he was appointed Director of Colville Tribal Forestry. His work for the Tribe will always be remembered by his individual efforts to bring BIA Forestry and Colville Tribal Forestry together in a joint effort to improve the level of Forest Management on the reservation – truly a lasting legacy.

SEPTIC SYSTEM DO’S AND DON’TS

In order for the Pueblo to pump out the septic tank, we first have to locate your residence. Please have house numbers posted on your residence. If your address includes an alphabetic letter, include this on your home as well. If we can’t locate your home, we won’t be able to pump the septic tank. When you call the Public Works office (505-869-5170) to request a work order for a septic pumping, be sure to include a good contact number so the driver can contact you if needed.


Clear access to the septic system must be maintained. Please move any vehicles, wood piles, or any other obstacles far enough away from the septic system so the septic truck can get close to the tank. Weeds need to be kept under control. Please do NOT burn the weeds, especially on the leach line portion of your septic system. Burning the weeds will damage the piping under the ground, rendering the leach field in-operative as the pipes will melt.

If the septic truck cannot get to your septic system, the tank cannot be emptied. It is the homeowners responsibility to ensure there is access to the tank. If there is not sufficient access, a door hanger will be left advising the tank could not be emptied and why. When access is available, the homeowner should call the Public Works office at 505-869-5170 to request a work order to have the septic tank pumped out. Public Works regular business hours are from 7:00am till 3:30pm. The septic truck driver plans out the route each day based on the location for each work order. The truck will hold 2,000 gallons, meaning about two tanks can be pumped before the tanker needs to be un-loaded. The driver will leave some liquid in each tank. This liquid has the necessary “bugs” to treat the incoming waste and is necessary to the septic tank treatment process.

Remember: Don’t put anything down the drains/toilets that can cause damage to the septic system. Grease, flushable baby wipes, paper towels, sanitary products, trash and excessive toilet tissue can cause sewage back-ups. Grease is the #1 cause of sewage back-ups. Tree/shrub roots are a close second. Plant trees and shrubs as far away as possible from your septic tank, sewer clean-outs and leach fields. Roots will search out sources of water (including wastewater) and once the roots get inside the pipe, the roots will grow in size, eventually creating a blockage in the piping.

If you have a slow draining sink or bathtub and have poured a harsh chemical down the drain, please advise Public Works/Housing employees that may later respond to help clear the back-up. Many products sold to clear drain blockages have an acid in them and are a hazard to you and the employees that may be trying to clear the blockage.

Purpose: The ITC Research Scholarship is designed to support tribally relevant, natural resource-based research being conducted by Native American scholars enrolled in a graduate program.

REQUIRED DOCUMENTS: The ITC Education Selection Committee will review and rank only those applications that completely address the following criteria:

- Letter of Application:** The letter must include your name, permanent mailing address, email address and phone number. Discuss your current educational program and how the tribally relevant proposed research fits into both your degree in natural resources and your future.

- Evidence of validated enrollment in a federally recognized tribe or Alaska Native Corporation,** as established by the U.S. Government. A photocopy of your enrollment card, front and back, or Certificate of Indian Blood (CIB) is sufficient.
- Mini Research Proposal:** Please keep this concise, 4 page maximum not counting budget and justification. Required elements include:
 - Abstract stating research merit and explaining how this research is relevant to tribal natural resource interests.
 - Timeline and methodology.
 - Dissemination plan, including a tribal component.
 - Budget and budget justification.
- Letters of Reference/Support.** Letters of reference are not accepted directly from referrals, submit with your completed application.
 - A letter of reference/support from an academic advisor or committee member is required.
 - A second letter of support from a tribal resource manager or a tribal representative with tribal approval of the project or the relevancy of the project to the tribe is required.

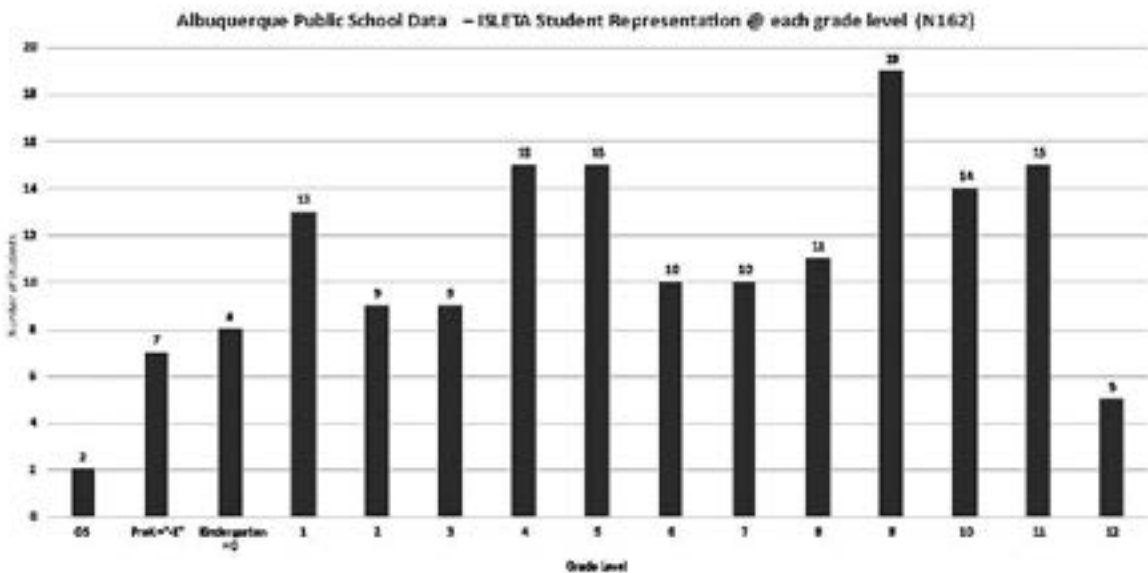
As of September 2023, there are 297 Native American High School students, 78% are on track to graduate and 22% are reclassified.

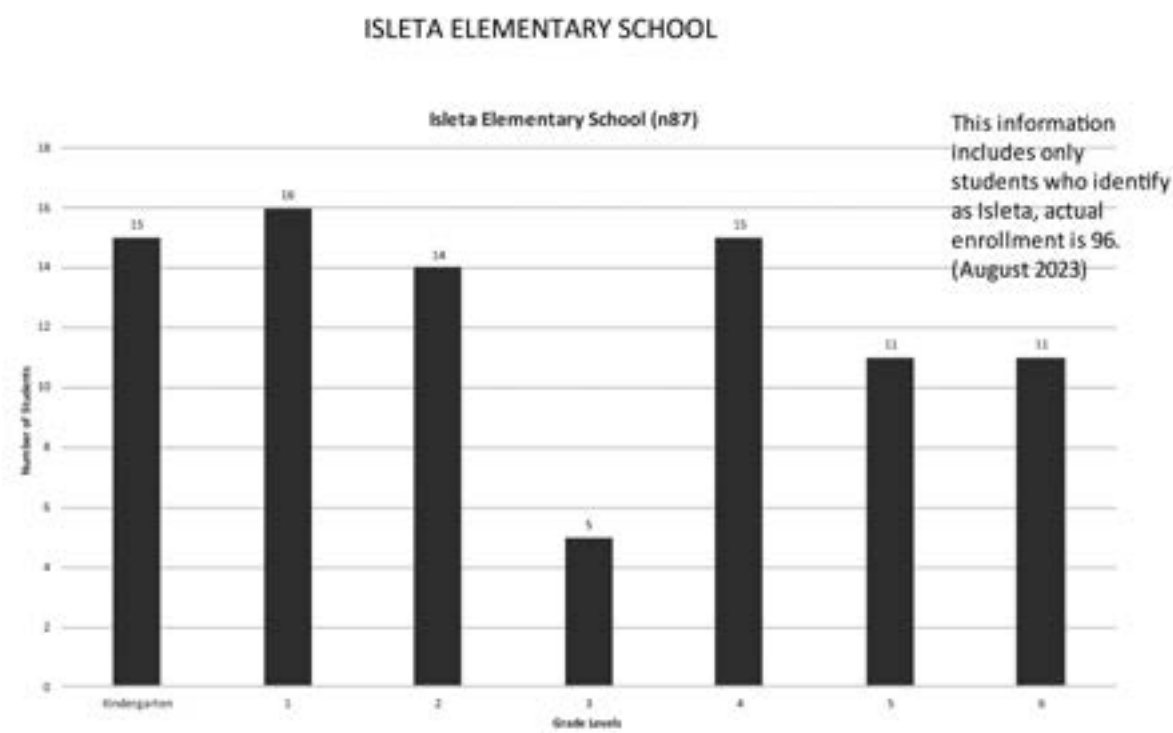

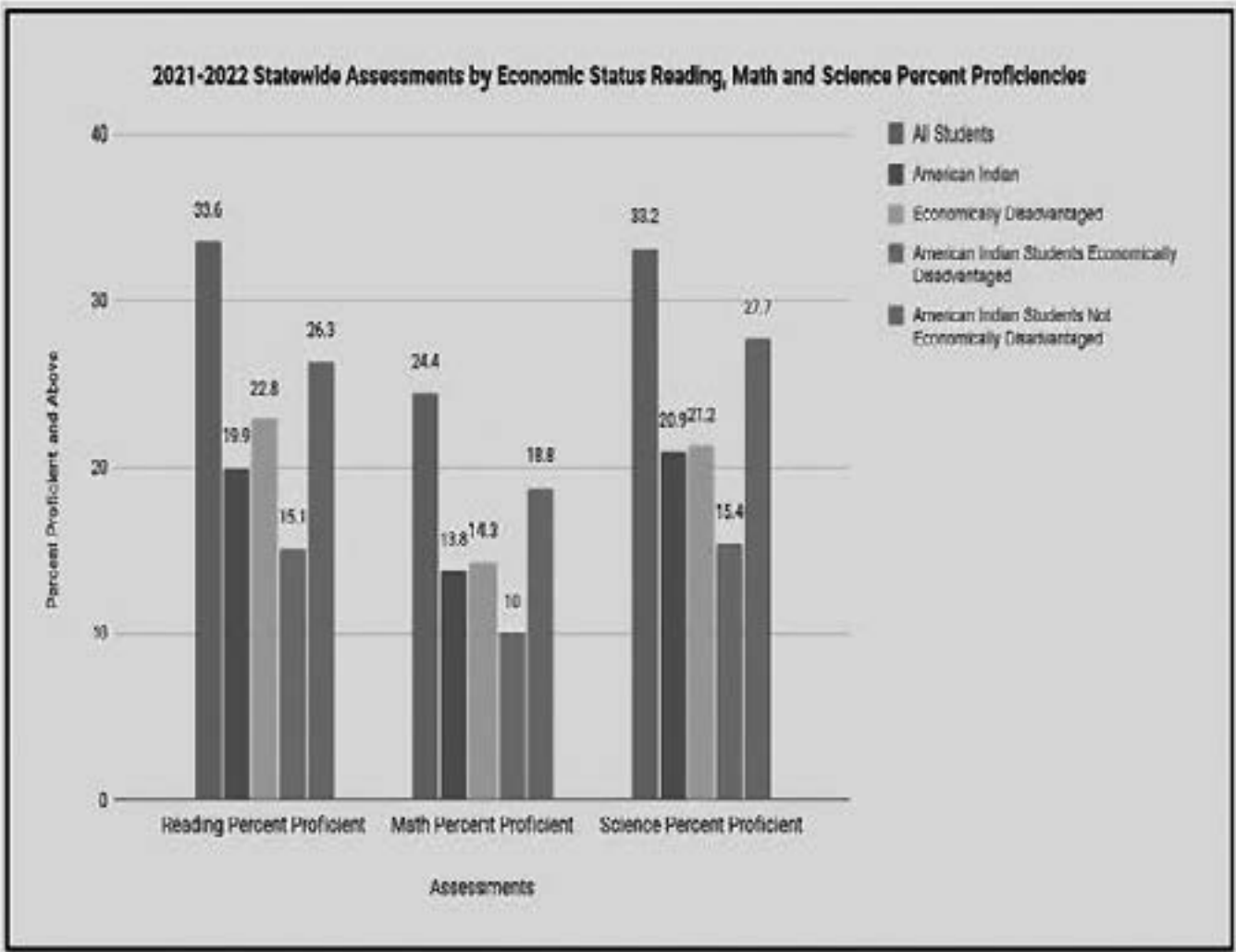

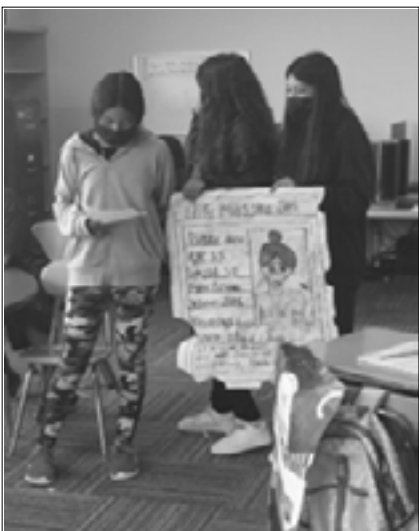

**REDUCE DROPOUT RATE, ABSENTEEISM
BY MAKING HIGH SCHOOL RELEVANT**

- To understand why students drop out of high school, researchers funded by the Gates Foundation hit upon a novel idea several years ago: Why not just ask the dropouts?
- So they did. Nearly half — 47% — of the respondents reported dropping out because they were bored. Their top suggestion to help students stay: Make school more engaging and enhance the connection between classroom and work. In other words, make the curriculum relevant.
- Given that New Mexico’s graduation rate is more than 10% below the national average and that 40% of our students miss more than 10% of school days, it would be wise to listen and provide students with opportunities to learn real world skills.
- Core requirements in English, math, science, and social studies offer a solid foundation of knowledge that all students should have, but students also need opportunities to engage in learning that is both practical and motivating, setting them up for post-secondary success. Required courses should include:
- Personal finance. A 2022 poll found that 89% of New Mexicans believed that completing a personal finance course is urgent for students. Twenty-three states, including six this year, have passed legislation requiring a one-semester course focused on basics like budgeting, savings, credit scores, and investing. Every student will need these skills upon graduation, if not before.
 - Civics. Public schools should prepare students not just for college and career but also should empower them to participate in civic life.
 - World language. New Mexico does not require a class in a language other than English even though bilingualism is a highly sought-after skill in today’s workforce. The Center on American Progress conducted a 2018 state-by-state comparison of graduation requirements and graded New Mexico as “deficient” in language requirements. Forty-nine


- state flagship universities require two years of language study, including UNM.
- Career and technical education (CTE). The U.S. Department of Education found that New Mexico high school students who take at least two CTE courses in a program area graduated at rates above 90%. Within CTE, students can explore everything from health care and film to teaching, journalism, and culinary arts while gaining skills relevant to their home and work lives.
 - Statistics and data analysis as an alternative to Algebra 2. New Mexico is one of only 11 states that requires Algebra 2 even though few adults use this knowledge. As recently as 2010, 20 states required Algebra 2, but many like Texas and Florida have abandoned the requirement. We agree with Senate Education Chairman Bill Soules that a more useful course would be statistics or data analysis, although Algebra 2 should still be offered in every high school.
 - Health and physical education. More than half of U.S. parents report having concerns with their child’s health and well-being. We can support students’ needs with at least one full credit of both.

Current state requirements include 24 total credits, which can be maintained by reducing the number of required electives from 7.5 to 4, still allowing students variety and flexibility to explore different careers or to follow a career pathway such as information technology, the arts, or health science.

Students should be provided with a well-rounded, comprehensive curriculum that exposes them to a diversity of subjects and gives them a strong foundation for life after high school.

Transit Services Now Serving the Pueblo of Isleta

The Pueblo of Isleta and the Rio Metro Regional Transit District Working Together

Bus Route 208 (No Fares until further notice!)

Bus Route 208 connects the Pueblo of Isleta and Valencia County communities to the Alvarado Transportation Center (ATC) in Downtown Albuquerque during the morning/midday when the Rail Runner does not operate. Route 208 features three northbound trips arriving at the ATC at 9:30am, 11:00am and 1:30pm, and three southbound trips departing the ATC at 9:35am, 11:05am and 1:32pm. At the ATC, riders can transfer to ABQ RIDE bus routes.

Route 208 serves two bus stops on the Pueblo of Isleta. The stop closest to the village proper is located on NM 147 just east of the Rio Grande Bridge. Please do not park and leave vehicles unattended on the adjoining roads near this stop, as the bus and other vehicles use these roads to turnaround and access other locations. Route 208 also stops at the Isleta Pueblo Rail Runner Station, where riders can transfer to the Isleta Resort and Casino shuttle. Because the bus serves the station, riders can also consider using Route 208 in combination with the Rail Runner, for example, taking the bus to Downtown Albuquerque in the mid-morning and returning by train in the evening.

Pueblo of Isleta Dial-a-Ride (No Fares until further notice!)

The Pueblo of Isleta Dial-a-Ride operates Monday through Friday from 8:15am to 2:45pm, providing trips within the Pueblo and to the ABQ RIDE Route 53 bus stop on NM 314. Service to places like Smiths, Albertsons and Wal-Mart in Los Lunas is also provided with requests made before noon at least one business day prior to your trip.

Request your Dial-a-Ride trip by calling Valencia County dispatch at (505) 352-3595 before noon at least one business day prior to your trip. Requests are accepted between 5:00am and 3:00pm Monday thru Friday. On the date and time of your trip, a wheelchair accessible van will arrive within 15 minutes of your scheduled pickup time. Trips may also be grouped together; riders should expect to travel with others.

Schedules for Route 208 are also available at the Public Services Department Office at the Tribal Services Complex.

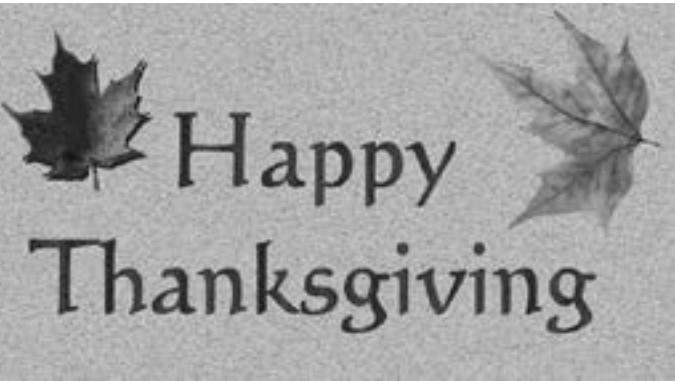

Isleta Community Health Assessment Results 2023

Thank you for everyone who completed the 2023 Isleta Health Center (IHC) Community Health Assessment Survey. The Isleta Health Center staff worked together on preparing a survey to improve the services that we offer the community. The surveys were disseminated throughout Isleta for 3 months (May 2023 to August 2023). They were disseminated at different programs and events and also collected during the Isleta Health Center's Health Fair on May 12, 2023, during the Isleta Environmental Fair and paper survey forms were also available in the Isleta Health Center lobby, the Governor's office, Isleta Environmental Dept, at the Isleta Elders Center, at the Isleta Tribal Complex and at a few other POI Programs. Links to the survey were also texted out via the POI Text messaging system, IHC Facebook and a link was available on the IHC website. With nearly 280 surveys collected, most of those that completed the survey were enrolled tribal members (91.6%), and the remaining were Isleta Health Center patients (37.3%) and Isleta Community Residents (29.3%), with the majority being female respondents (72.8% female, 26.5% male and .7% preferring not to respond). Most people that completed the survey were over the age of 50 (64% were over the age of 50), with 18.2% 50-59yrs old, 21.9% 60-69 years old, 19% 70-79 years old, 4.5% 80-89 years old and .4% 90-99 years old. Thirty-six percent (36%) were under the age of 50, with only 12.3% 40-49 years old, 11.5% 30-39 years of age, 9.3% 21-29 years old, 1.5% 18-20 years old and 1.5% were under 18 years of age.

We really appreciate everyone that completed the survey. We learned many great things from this survey. To start, the respondents stated what they like best about the Isleta community. The top four were:

- Family
- Community
- Traditions
- Services

It was also helpful to learn that not quite half the participants use Facebook regularly (44.7%), with nearly 40% of the respondents stating that they don't use social media regularly. When asked how they get health information, the majority stated they get it from the POI Community newsletter (56.9%), 47.7% said from the IHC Newsletter and 36.5% said from Health Fairs, these responses didn't change much from the 2019 IHC survey. When asked how they like to be notified of IHC Programs 66.5% stated from the POI Community Newsletter, 50.6% stated the IHC Newsletter and 46.7% stated Text Message Announcements. When asked what IHC Services they use, the majority (79%) use the pharmacy and the Dental Clinic (76.8%). Look at the graph to see the responses.

When asked why they do not use services, the largest responses were that the appointment time options were inconvenient (33.7%) and that people were not confident in the IHC services (32.6%). When asked what additional medical services are needed, the 3 largest responses were Radiology (74.2%), Ultra Sound (51.2%) and Home visits by Community Health Representatives (39.1%). We were glad to see that the majority of people are satisfied with the Isleta Health Center Programs, with 52% somewhat satisfied and 31.2% extremely satisfied.

When asked what programs they are interested in attending the top 5 programs were Healthy Cooking classes (56.5%), Grocery Bingo (46.4%), Diabetes Fitness Programs (42.6%), Health Education Group (32.1%) and suicide prevention education (27.4%). The location that people would most like to attend an event is at the Isleta Health Center (54.7%), Isleta Casino Conference Rooms (52.7%) and the Isleta Rec Center (new) (39.8%). When asked the time most likely to attend an event 46% stated weekday evenings. When asked for Diabetes Prevention Programs, most were interested in learning what they should eat (56%) and how to prevent diabetes (47.7%). Out of those that use the Diabetes Prevention Program, the majority of people are somewhat to extremely satisfied. Moving onto the pharmacy services, 76% stated current pharmacy hours are convenient, but 87.6% still stated they would use the pharmacy if they had extended hours. Only 62.9% stated they use the pharmacy refill line to call in meds. 82.7% stated they want a pharmacy drive through window. When asked if you know the medications they take, only 83.3% of people stated they do, while 84.5% stated they know why they are taking the medication.

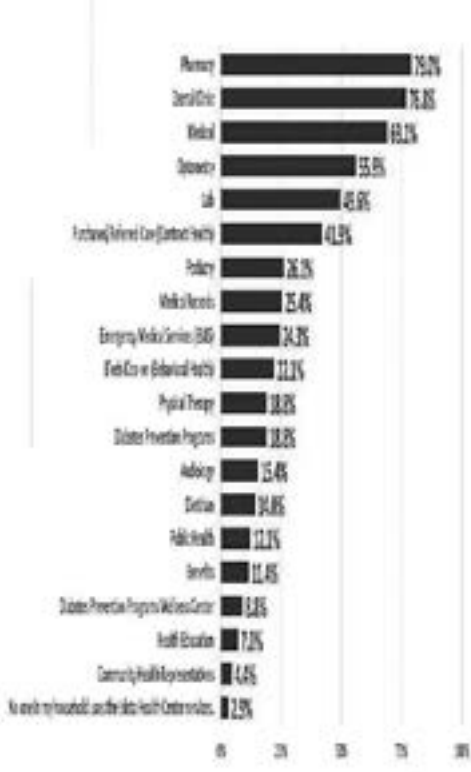
When asked if they would use the clinic after-hours, only 47.3% stated they would for primary care, while 84.5% stated they would use it for urgent care. When asked if they were satisfied with medical services, 84.3% were satisfied (36% extremely/48.3 somewhat). When asked about Physical Therapy, only 63.9% were aware that the Isleta Health Center has Physical Therapy, which the majority stated they waited less than 2 weeks to be seen.

Out of a list of several issues children under 17 could experience, the majority responded that they experience bullying (11.3%) and alcohol (9%). The majority of people stated they had received a flu shot in the past 12 months (69.9%), with those that did not receive one stating they didn't receive it because it was not available (72.7%) or they didn't know where to go (10.9%). 72.6% stated they received a COVID shot in the past 12 months, with 14.1% those that did not receive a COVID Vaccine, stating they were concerned about safety as being the reason they did not receive it. 75% of respondents stating they participated in physical activity in past month, with the majority (37.6%) stating they are active 3-4 days a week, with 42.8% wanting to lose a few pounds.

When asked if they have ever thought of suicide, 10% said yes and of those that said yes, 40.7% said it was in the past few months, with 11.1% having a specific plan. When asked if they ever actually tried to commit suicide, 4.3% stated yes and of those, 10% said they tried in the past year. 24.6% stated suicide has affected their life. 7.8% of participants are current cigarette smokers and have smoked at least 100 cigarettes. When asked which product they use, the majority that answered said none (79.2%), followed by 10.6% stated cigarettes and 4% E-cigarettes/Vape. 6.8% (~12 people) stated they would like help quitting these products. 2.9% state they use cannabis/marijuana daily (~7 people). When asked if people use alcohol more than you want to/think you should, 6.3% (~16 people) said yes.

When asked if Isleta needs a Residential Alcohol/Drug Treatment Program, 78.9% stated yes. When asked if anyone harmed or threatened you in the last 3 months, 6.4% stated yes, when asked if you are having housing difficulty, 9.6% stated yes, while 10.5% stated food in their household did not last and they didn't have money to get more. Only 53.1% knew where to get food support. 26% stated they want CHR to work with them one on one, with the majority stating they want help understanding health conditions, treatment and setting goals to live a healthier life.

The Isleta Health Center is working on addressing the concerns that were discovered from the Isleta Community Health Assessment Survey, so please keep an eye out for upcoming educational events, resources and programs. We also plan to have monthly articles that discuss the survey results more in depth. Again, thank you to those that completed the survey and congratulations to the 15 participants that received a gift card through the random raffle we had for all those that completed the survey.

Helping Your Adult

Family Member

Who Has an Addiction

Although you may be tempted to rescue, bribe, pamper, scold, or threaten your adult family member who continues to use and abuse alcohol and/or drugs, this is not a helpful approach.

Families share experience, strength, and hope at Al-non meetings. These meetings teach you how to stop “enabling”. The word enabling means “allowing, permitting, or aiding” the alcoholic/addict to stay in their sickness and enabling keeps you, the family, trapped in the problem. Enabling can make you physically and emotionally sick and cause increased stress with you and your home environment. Addiction is not something that affects just the alcoholic/addict but has a negative impact on the entire family and the community.

No one wants their adult family member to suffer with an addiction and your intentions to help are out of love and concern. When enabling turns into an intervention, things begin to change. It is time to take your focus off the adult family member’s addiction and place it onto yourself and your family. You regain power to make meaningful choices about what you will do and what you won’t do. Enabling does not teach responsibility.

Eye Health for Adults Over 60

See your eye doctor regularly!

First and most important, it is recommended that you have your eyes examined by an optometrist or ophthalmologist at least once per year. You will be screened for eye diseases such as glaucoma or macular degeneration. If these are identified early, you can work with your eye doctor to preserve your vision for many years to come.

Maintain a healthy lifestyle!

Conditions such as Diabetes and High Blood Pressure can affect your eyes. It is very important to work with your Primary Care Doctor to maintain healthy blood sugar and blood pressure. A healthy lifestyle not only helps the body, but also helps the eyes.

Use the right eye drops!

Dryness of the eyes is very common with age. It is recommended that you use eye drops for lubrication, also known as “artificial tears”. Avoid drops that say, “get the red out” as these can actually make the eyes feel more dry. Instead, look for drops that say “lubricating” or “moisturizing”. If you are not getting sufficient relief, talk to your eye doctor about other options.

Be aware of normal aging changes to your vision!

The eyes change with time. Driving at night and moving from dimly lit to well-lit areas become more difficult. Be extra cautious while driving, especially at night. You may also find that good quality lighting will improve your ability to read and do other near tasks.

Wear Sunglasses!

Good sunglasses with UVA/UVB protection will help to slow the progression of cataracts and other eye damage that can be caused by UV light. Wide-brimmed hats can also help to decrease the UV light that enters the eyes.

Diabetes Awareness Month

THERE ARE 2 TYPES OF DIABETES

Type 1- known as juvenile or insulin dependent diabetes. The exact cause is unknown but the body’s immune system attacks the insulin producing cells in the pancreas which are needed to process glucose in our body. Insulin is required to treat this type.

Type 2- cells in the muscle, liver and fat become resistant to insulin which is needed to transport sugars into cells of the body, this causes a raise in blood sugar levels. There are four stages to this type. They are insulin resistance, pre-diabetes, type 2 diabetes and type 2 diabetes with vascular complications. The condition develops over time and most people with diabetes have this type. Factors such as weight and genes are contributing factors.

SYMPTOMS

The symptoms include: being overly thirsty and using the restroom frequently; blurry vision; tingling in the hands and feet; wounds that are slow to heal; and, weight loss without trying.

WHAT YOU CAN DO

Diabetes can be managed through diet and drugs such as Insulin and Metformin. A care team needs to be established with a primary care doctor, endocrinologist and dietitian. Lifestyle changes such as weight loss, healthy eating and exercise benefit an individual and manage symptoms.

News Flash for WIC Clients

WIC Cash Value Benefits Extended through November 17, 2023

The cash value benefits (CVB) increase has been extended for issuance through November 17, 2023. This means participants can continue purchasing more fruits and vegetables at authorized POI WIC vendors through **November 30, 2023**.

The new CVB amounts for fruits and vegetables are:

- \$25 monthly for children
- \$44 monthly for pregnant and postpartum participants
- \$49 monthly for fully and partially breastfeeding participants
- \$73 for mothers breastfeeding multiple children

Participants who received benefits for October and November prior to October 1, 2023 were not issued this benefit and need to return to the clinic if they would like to receive the additional amount. Any other questions from participants, please advise them to return to their clinic.

All WIC policies related to approved fruits and vegetables still apply and have not changed. For questions regarding this please contact the Pueblo of Isleta at (505) 869-2662.
