Albuquerque Bernalillo County Water Utility Authority reported an exceedance in the concentration of E. coli at its outfall, which is where treated wastewater flows into the Rio Grande at the Southside Water Reclamation Plant (SWRP) located south of Rio Bravo Blvd. On August 5, 2024 a grab sample measured over 2,519 CFU per 100 ml. The following day, on August 6, 2024, the compliance E. coli grab sample at the same point of collection was 4.1 CFU/100 ml. The UV system was inspected for deficiencies by the SWRP and none were found. POI Environment collected water quality samples from the Rio Grande at NM 147 and west of Isleta Lakes:

\*Water quality samples are collected on a monthly basis from the Rio Grande except Indian Interior Drain at 240 Wasteway, Albuquergue Riverside Drain, and the irrigation locations.

"MPN" is a unit of measure that stands for most probable number. MPN is equivalent to colony forming units ("CFU").

The Pueblo of Isleta's most stringent surface water quality standard for E. coli bacteria is 88 MPN/100 ml at all times and at all flow rates.

Please continue to watch signage at the NM 147 bridge for surface water quality advisory. No fishing or swimming is allowed on the east and west side of the Rio Grande River nor ditches by Order of the Governor; please follow all signs posted regarding Governor's order.

# COALITION TO STOP VIOLENCE AGAINST NATIVE WOMEN

The Coalition to Stop Violence Against Native Women (CSVANW) is proud to announce that Executive Director, Tiffany Jiron, and Policy & Communications Coordinator, Ryder Jiron, represented the organization at a prestigious event at the White House on <u>Thursday, September</u> 12, 2024. The event marked the 30th anniversary of the Violence Against Women Act (VAWA), a landmark piece of legislation that has played a crucial role in advancing the protection and empowerment of Native American women.

"Attending this event at the White House was a momentous occasion for CSVANW and for all of us dedicated to protecting Native women and girls," said Tiffany Jiron, Executive Director of CSVANW. VAWA has been a lifeline, but there was still much work to be done. The reauthorization of VAWA represented a significant step forward, yet we must continue to advocate for increased funding for Tribal Nations and a complete Oliphant fix. Our women are the heart of our communities, and their safety is integral to preserving our sovereignty, cultures, and languages.'



Since its enactment, VAWA has been a critical tool in the fight against genderbased violence. The 2013 and 2022 reauthorizations brought significant progress by including key tribal provisions that recognized and strengthened tribal jurisdiction, allowing tribal nations to prosecute non-Native offenders who committed crimes against Native women on tribal lands.

The anniversary celebration served as a crucial reminder of the progress made and the ongoing efforts needed to address and prevent violence against Native American women and their communities. CSVANW remains committed to advancing these efforts and ensuring that the voices of Native women are heard and their rights are protected.

# LETTER FROM THE EDITOR

People who wish to submit an article or flyer are responsible for generating their own article or flyer. Should you need help, please call the Library at 505.869.9808 and set up a date and time to sit down with a Library staff member who will help you throughout the process. The Library will NOT accept notes dropped off at the Library or information over the phone to generate your article.

**PROBATES** need to be published in the Newsletter for two consecutive months. Probates are considered court documents, therefore, all submitters must provide: 1) Name of Deceased, 2) Date of Deceased 3) Court Case # and 4) Date of Court Date. A Probate form can be found on the Newsletter Archive page at http://www.isletapueblo. com/newsletters.html.

**CLASSIFIED ADS:** The new administration has requested that the Newsletter start a Classified Ad section for Tribal members selling land, houses, mobile homes, vehicles, and farm equipment. Leasing of houses and mobile homes will be accepted. Smaller items which can be sold at the local flea markets or weekly yard sales will NOT be accepted.

Currently, this service is FREE to Tribal members. Land, houses, and mobile homes must be within the reservation boundaries. Ads must meet the 160 character limit. Ads that exceed the 160 characters will NOT be submitted into the Newsletter. A single picture may be submitted with the ad. Submitters of classified ads are responsible for generating their own ads as this is a FREE service.

As a reminder, Tribal business owners may submit a small flyer at no charge. Like the classified ads, business owners are responsible for generating their own flyers as this is a FREE service.

Classified ads and business flyers will be posted no more than two consecutive months. In the event where the Newsletter may exceed the 24-page limit, classified ads and business flyers will be "bumped" for newsletter articles. Again, this is a FREE service for Tribal members.

The Isleta Newsletter is owned and operated by the Pueblo of Isleta. Therefore, the Governor of the Pueblo of Isleta has the final say of all articles and contents within the Isleta Newsletter.

# **PUBLIC WORKS - PUEBLO OF ISLETA**

Eastside Sewer Collection System Project Update

Project Overview: Remove septic systems with new E-One grinder pumps at homes to connect to main sewer line for the Eastside residents.

Public Works hosted a public meeting for Ranchitos residents for phase 1 of the project. The meeting was held on Monday August 26,2024 at 6pm at the Reception Hall. Prior to the meeting, all households received a hand delivered notice of meeting and a mass text reminder was sent out. 24 out of 123 homeowners attended. The meeting covered topics such as an update on the project and what is to be expected in the upcoming months.

Some concerning questions that were asked:

1. Who will pay for the cost of the pump replacement? Answer: Based on funding availability, Public Works will take care of it.

2. Will work be done in farm line property? Answer: All work will be done at the edge of all lands as much as possible.

3. Will communication happen one on one with homeowners? Answer: Yes, this will happen on a case-by case basis.

4. How long will repair happen when something goes out? Will pumps be on hand? Answer: All issues will be placed through Public Works work order system and be addressed based on priority. Yes, pumps and parts will be on hand.

5. What is capacity of storage when power goes out? Answer: 75-200 gallons

6. Can you opt out? Answer: This decision will be addressed to Administration and they will be the one to make the final call.

We understand there is a lot of questions and/or concerns that are still out there and we want to hear them!

A copy of the power point provided by our designer is available for pick up at the Public Works Office.

Please be on the lookout for more public meetings as this project continues to come together. It is very important to attend these meetings as we welcome all input, concerns, and questions.

Residents along Highway 47 can expect surveying crews in the area white lining the sewer alignment for this project.

# TIME TO PREPARE FOR THE COLD

Colder temperatures are here. Time to protect your plumbing from the freezing temperatures. Sewer piping can freeze – especially underneath a modular home. Take time now to check your piping – both water and sewer lines. Any exposed water or sewer pipe should be protected with heat tape, insulation or other means to help prevent the pipes from freezing. If you have a modular home, please ensure the skirting is in good condition and if there is no skirting, do what you can to protect the underside of the home from the cold.

Swamp coolers should be properly winterized. The water supply line should be removed from the spigot or frost free and drained. Frost frees should not be left in the open position; remove any hoses from the frost free and close the frost free. When left open, the frost free cannot drain the water that is inside the unit. The frost free is designed to drain itself when the handle is put in the closed position, which should prevent freezing.

Homeowners should know where the main shut off is to their residence. Most homes have an interior and exterior shut off valve. Toilets and sinks should have isolation valves going directly to the fixture. The purpose of isolation valves is to isolate water leaks or breaks occurring inside and/or outside the home. Have you ever tested these isolation valves to ensure they work? Take time before colder weather moves in to locate these valves and ensure they are working.

Locating the exterior shut-off may be challenging.

Take time to locate your exterior shut-off while it is not an emergency situation. Placing a marker of some type near the shut-off will save time in the event you do have an emergency and need the water shut-off as soon as possible. It takes time for a Public Works crew to be dispatched to assist you, especially after normal working hours. It helps Public Works when the resident/s know where their exterior shut off is. When shut off is known, water damage in the home is prevented and time is saved allowing help to get straight to the water issue at hand.

Again, be prepared and protect your piping from the cold; check the isolation valves at each fixture; know how to turn off your water in an emergency; and locate and mark your exterior water shut-off.

# **RESOLUTION No. 2024-096**

# NOVEMBER 2024 PER CAPITA DISTRIBUTION AUTHORIZATION

At a duly called meeting of the Tribal Council of the Pueblo of Isleta, held on September 17, 2024, the following resolution was passed:

**WHEREAS,** the Pueblo of Isleta (the "Pueblo") is a federally recognized Indian Tribe organized pursuant to its Constitution adopted in accordance with the Indian Reorganization Act and with the inherent powers of self-government;

WHEREAS, the Pueblo is governed by a Governor and Tribal Council made up of elected representatives who act in accordance with the Pueblo of Isleta Tribal Constitution ("Constitution");

WHEREAS, Article V, Section 2(i) of the Constitution authorizes the Isleta Tribal Council to "appropriate such funds as necessary for the health, safety, and general welfare of the pueblo, for other public purposes and per capita payments to members of the pueblo;"

WHEREAS, Article V, Section 2(1) of the Pueblo of Isleta Constitution authorizes the Isleta Tribal Council to "otherwise manage and control the lands and resources of the pueblo for the best interest of the pueblo;"

**WHEREAS**, the Tribal Council finds that it is in the best interests of the Pueblo of Isleta to authorize a November 2024 per capita distribution to all enrolled Tribal Members, regardless of their place of residency;

WHEREAS, the distribution under this Resolution shall be made first from the Proceeds of Labor Account held at the Bureau of Indian Affairs Office of Trust Funds Management and

second from the Pueblo's Wells Fargo Bank Per Capita Account in an amount not to exceed \$3,783,750.00 for purposes of this per capita distribution.

WHEREAS, the Tribal Council has determined that it is in the best interests of the health, safety, and general welfare of the Pueblo to issue such distribution pursuant to the criteria described herein;

**NOW THEREFORE BE IT RESOLVED,** the Tribal Council hereby authorizes the November 2024 Per Capita distribution as follows:

### 1. Definitions:

a. "Tribal Member" shall mean a person enrolled with the Pueblo of Isleta as a Tribal Member and approved by Tribal Council or Tribal Enrollment Committee as of September 20, 2024.

### 2. Criteria for Distribution:

- a. A Tribal Member must be an enrolled Tribal Member as of September 20, 2024 to be eligible for the November 2024 Per Capita Distribution.
- b. All eligible Tribal Members will receive a per capita distribution \$750 to be distributed by the Treasurer's Office, as described below in "Distribution Procedures."

### 3. Distribution Procedures:

- a. Distributions for in-state Tribal Members will be made by check and should be picked up in-person, unless the Tribal Member provides an original, notarized letter requesting their distribution to be sent via certified mail pursuant to Section 4(b).
- Except for those qualifying for the distribution procedures described under Section 4 below, all Tribal Members must pick up their checks in-person on Friday, November 8, 2024, from 7:00am to 7:00pm at the Isleta Main Recreation Center. A Tribal ID or valid driver's license must be presented to receive the distribution.
- c. Alternatively, Tribal Members may pick up checks from the Treasurer's Office Mondays through Fridays during normal business hours, 8:00am to 4:30pm from November 12, 2024 through January 31, 2025.
- All distributions hereunder must be deposited or cashed by a bank by February 21, 2025. Any checks not cashed prior to that date shall be null and void.
- 4. Distribution Procedures for Those Unable to Pick up a Distribution Check in Person

- meetings are quarterly and from 5 pm to 7 pm.
- 5 IPHA Board of Commissioners: Meetings are 2-4 hours, 2-3 times a month.
- 2 Tribal Enrollment Committee Members: Meetings are as needed, according to caseload, but typically twice a month 9 am -12 pm.
- 5 Election Board Members

- a. A Tribal Member who is out-of-state or otherwise unable to pick up their check in person at the Recreation Center during the designated dates or from the Treasurer's Office during business hours may provide an original, notarized letter designating another individual to pick up their distribution check on the unavailable Tribal Member's behalf.
- b. A Tribal Member who is out-of-state or otherwise unable to pick up their check in person may also provide an original, notarized letter to the Treasurer's Office requesting that their distribution be sent via certified mail. The notarized letter must include the address to which the distribution check should be sent, copy of valid Isleta Tribal ID or valid driver's license, Isleta Tribal Census Number and current contact information. A Tribal Member requesting their distribution be sent via certified mail must request that the Treasurer's Office do so by January 31, 2025. Any checks returned to the Treasurer as undeliverable or otherwise returned shall be void, no longer available, and shall not be reissued to the intended recipient after February 21, 2025.
- c. All distributions, including those sent via certified mail, will be null and void if they are not cashed and cleared by a bank on February 21, 2025.

- a. November 2024 Per Capita Distribution checks will be issued to minors directly and shall not be routed to their Bureau of Indian Affairs Individual Indian Money account.
- b. Per Capita distribution checks for Tribal Members under the age of 18 shall be picked up by the minor's parent, or legal guardian, or custodian, in accordance with the records of the Isleta Tribal Court and Census/Enrollment Department. The Treasurer's Office shall not issue a distribution check to a minor's parent if the parent is not a custodial parent or legal guardian. If there is no custody documentation on file with either Isleta Tribal Court or the Census/Enrollment Department, the Treasurer's Office will provide the distribution check to either parent or legal guardian of record.
- c. If a minor Tribal Member is a ward of the Isleta Tribal Court, Isleta Social Services shall pick up the distribution check on the minor child's behalf.

### 6. Withholding of Distribution:

The November 2024 Per Capita Distribution shall not be subject to any withholdings, including but not limited to garnishments, fees, restitution, and child support.

### 7. Funding Sources:

An amount not to exceed \$3,783,750 may be withdrawn from the accounts as detailed herein to fund the November 2024 Per Capita Distribution. The Distribution is non-taxable.

BE IT FURTHER RESOLVED, that the Governor, Treasurer, and Census Office are authorized to do all that is necessary to effectuate the intent of this Resolution;

BE IT FURTHER RESOLVED, that the Tribal Council authorizes the Treasurer to mail per capita distributions issued to Tribal Members pursuant to the procedures describe in this Resolution and appropriates an amount not to exceed \$6,200.00 to the Treasury budget to send the distributions via certified mail; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon adoption by the Tribal Council and shall remain in effect until otherwise superseded or repealed by Tribal law.

# **CERTIFICATION**

We, the undersigned, do hereby certify that the foregoing resolution was passed at a duly called meeting of the Tribal Council of the Pueblo of Isleta, held on the 17th day of September, 2024, at which a quorum was present, with 5 voting for, 1 opposing, and 1 abstaining.







As we approach October, fall break and midterms usually fall within this month. Whether you're a college freshman or graduate student, midterms can make you nervous, however midterms are part of the college experience.

Here are some tips to help you be prepared and ready to tackle those midterm exams:

1. Review your class syllabuses to find out when your college midterms are scheduled.

2. Attend your professors' office hours, do not be afraid to ask for help or ask questions if you are not understanding the assignment.

3. Study, study, study. Studying your notes, class courses, and class materials can help ease the burden of late-night cramming and feel prepared for your exam. Create study groups with your fellow peers.

4. Prioritize Rest and Mental Health. Taking exams can be stressful and test anxiety can make it difficult to perform well on midterms. Remember to take care of yourself, take breaks, and get enough sleep. Cramming for midterms the night before can backfire.

5. Find a study method that works for you.

6. Look at the whole exam before you start answering questions. And remember to read the instructions.

7. Finally, it's going to be okay. Breathe, do not stress yourself out. Replace negative thoughts with positive ones. Remember mistakes are learning opportunities. A wrong answer on a test is an opportunity to understand where you need to fill in the gap of your knowledge or spend extra time studying.



Our second project was to design paper airplanes and then work together to solve the issues with flight, until they found the best strategies. Team 2nd/3rd grade is soaring!












With the rains that have been occurring, please ensure your tires are not worn and remember the first few minutes of rainfall cause oils to rise to the surface thus making the roads slick. Drive with caution and slow down during the onset of the rains.

As Halloween is this month, parents/guardians, please be sure to check your child's candies before allowing them to eat as there have been incidents, not necessarily on the pueblo, where individuals have placed items such as straight pins and razor blades in them. Also be aware because of the drug trends that have been arising there are narcotics such as Fentanyl, some which are described to resemble Fentanyl know as "rainbow Fentanyl".

# BEWARE

During the month of October, the police department was contacted by individuals reporting incidents that occurred in various parts of Albuquerque, and after conducting a bit of research, we found some articles of the same type of occurrences happening in 2023.

Each of these individuals while completing their shopping and returning to their vehicles, discovered money lodged under the windshield wiper, most were not in large denominations (three to five dollars) and not immediately visible. The first incident, the wife of the party who contacted the department was instructed not to get out of the vehicle (by her husband) to retrieve the currency, but instead drive home and contact local police which was done. She was told by Albuquerque Police Department there were no other occurrences reported within the city but did take her information.

There have been instances in the midwest and east where larger denominations of counterfeit cash were placed under the wiper, in plain view. When the driver, after starting the engine, saw the money and got out to retrieve it, the offenders would forcefully take the driver away from from or out of the vehicle and steal the vehicle (a carjacking, if you will). Please be aware of this as it could be a trend starting here in Albuquerque. A warning to always be watchful and aware of your surroundings after work, after shopping or after being out for the day or evening. It is apparent there is crime occurring everywhere and IPD asks everyone to be vigilant and stay safe.

# **TRAFFIC SAFETY**

Traffic safety remains a top priority for the police department. The Isleta Police Department is a proud recipient of the Bureau of Indian Affair's Indian Highway Safety Program (IHSP) Grant, which provides essential traffic safety funding to our Pueblo. Each year, officers and administrative staff members with the IHSP along with police department leadership attend the Governor's Highway Safety Association conference. At this conference, the police department has an opportunity to attend breakouts sessions to learn new traffic safety strategies being implemented to improve overall motorist and pedestrian safety. Additionally, the police department networks with other government entities, federal funding entities, and traffic safety vendors to share and/or learn about how each of them are improving traffic safety. We are committed to reducing crashes, especially those resulting in fatalities or serious injuries, along with impaired driving incidents.


### IF YOU BAG RECYCLABLES DO NOT USE BLACK OR WHITE BAGS

Keep it simple, if you do not see it on this flier throw it away in the trash. Do not use your blue recycle cart for trash or it will be confiscated. Have your cart out by 7am. For service schedule announcements check the POI newsletter & POI Facebook. (505) 869-4106

Your recyclables do not need to be bagged, however it is highly recommended to bag your recyclables for curbside pickup during windy season. This is to reduce the chance of creating litter due to winds. If you choose to bag your recyclables it is important to use clear bags only. Colored bags are not accepted at the recycling facility. When your recyclables are bagged in colored bags they are not opened up and your material is landfilled instead of recycled. Using clear bags helps to ensure the health and safety of the line workers who come in contact with the material when sorting at the recycle facility. Using colored bags will result in your recycles not being collected. This is important to sustain the recycle program moving forward. Your understanding and cooperation is greatly appreciated.

Saturday and Sunday hours are 7AM - 3PM. The Transfer Station is closed on Tribal & Federal Holidays. The last large load is accepted 15 minutes before closing time. For your safety we may close due to high winds. For use of tribal members only, must have a tribal member present when utilizing the facility. # Health Beat: Breast Cancer Awareness Month

Breast Cancer Awareness Month, held in October every year. aims to promote screening and prevention of the disease, which according to the American Cancer Society, accounts for about 30% (1 in 3) of all new female cancers each year. Breast Cancer mainly occurs in middle ages and older women, with half of women developing it at 62 years age or younger and <sup>1</sup>/<sub>2</sub> developing it over the age of 62. There is a 1 in 8 chance that a women will develop breast cancer, which also means that there is a 7 in 8 chance that a woman will never have the disease, however, for those that do get it, it is important to catch it early. Which is why we are helping increase awareness for this disease by WEARING PINK in October. PINK is the color of the breast cancer awareness ribbon and wearing pink in awareness of this can help remind people of the steps they can take to prevent or catch breast cancer early. Join the Isleta Health Center Staff in celebrating this awareness month by wearing Pink on Fridays in October. One reason why we wear pink in October is to promote the importance of regular screening, starting at age 40 or an age that is appropriate for your personal breast cancer risk.

# Have you had your mammogram lately? Annual screening is recommended at age 40yr.

# Risk Factors You Can't Control

- Gender -Women are more likely to develop breast cancer than men, however, men can develop it too.
- Genes A genetic predisposition is felt to be responsible for 5 to 10% of breast cancers.
- Race Whites are more likely to develop breast cancer than other races.
- Age The risk of breast cancer increases with age.
- Drugs and treatments Some medications may increase and others decrease risk.
- Start of period and age of menopause- An early age of menarche (first period) or late menopause increase the risk of breast cancer.
- Medical radiation to the chest Radiation therapy to the chest, for example for Hodgkin's disease, increases the risk of breast cancer, especially radiation at a young age.
- Dense breasts Women with dense breasts are more likely to develop the disease than women without dense breasts.

# Risk Factors You Can Control

- Pregnancy 1st child after age 35.
- Breastfeeding For a total of 1 year or more (combined for all children) lowers the risk of breast cancer.
- Hormone replacement therapy Some forms of hormone replacement therapy may increase risk
- Alcohol
- Smoking
- Diet
- Exercise

- Be physically active (30 minutes is ideal, but any amount it good).

- Get regular mammograms (yearly after age 40)
- Don't smoke (Call 505-869-4479 for help quitting).
- Limit alcohol (Call 505-869-4575 for help).
- Breastfeed for at least 1 year.
- Avoid Birth Control Pills particularly after age 35 or if you smoke.
- Avoid Menopausal Hormone Therapy.
- Understand your family history.

# Vaccine Recommendations for the 2024-25 Respiratory Disease Season

# COVID-19

- Everyone ages 6 months and older should get an updated 2024–2025 COVID-19 vaccine. This includes people who have received a COVID-19 vaccine before and people who have had COVID-19
- The COVID-19 vaccine helps protect you from severe disease, hospitalization, and death.
- It is especially important to get your 2024–2025 COVID-19 vaccine if you are ages 65 and older, are at high risk for severe COVID-19, live in a long-term care facility, or have never received a COVID-19 vaccine.
- Vaccine protection decreases over time, so it is important to stay up to date with your COVID-19 vaccine.
- Getting a COVID-19 vaccine is a safer, more reliable way to build protection than getting sick with COVID-19.

# Seasonal Influenza

- Everyone 6 months of age and older should make a plan to get an updated flu vaccine.
- All U.S. flu vaccines for the 2024-2025 season are trivalent (three component) vaccines that protect against three influenza viruses: an A(H1N1) virus, an A(H3N2) virus, and a B/Victoria virus.
- People age 65 and older and people who have received a solid organ transplant can opt to receive a "high dose" flu vaccine
- Flu vaccination can keep you from getting sick from the flu.
- Flu vaccination can also reduce the risk of hospitalization from flu as well as the severity of illness even if someone gets sick with the flu.

# **RSV Vaccine**


- Recommended for all adults age 75 and older if they did not receive a previous RSV vaccine last season.
- Recommended for people ages 60–74 who are at increased risk of severe RSV, meaning they have certain chronic medical conditions, such as lung or heart disease, or they live in nursing homes.
- The RSV vaccine is not currently an annual vaccine, meaning people do not need to get a dose every RSV season.
- Eligible adults can get an RSV vaccine at any time, but the best time to get vaccinated is before RSV starts to spread in communities.




leagues, playing baseball, and trying any new physical activity that catches my eye.

# Understanding Bullying – Working in the Community B'eeh K'oo-ee Wellness Center

Bullying can include aggression that is physical (hitting, tripping), verbal (name calling, teasing), or relational/ social (spreading rumors, leaving out of group). Bullying can also occur through technology/social media platforms known as cyberbullying. Electronic aggression is bullying that occurs through e-mail, a chat room, instant messaging, text messaging, and videos/pictures posted or shared through social media.

Bullying can result in physical injury, social and emotional distress, and even death. Victimized youth are at increased risk for depression, anxiety, sleep difficulties, and poor school adjustments. Youth who bully others are at increased risk for substance use, academic problems, and violence. Youth who are victims to bullying suffer the most serious consequences and are at greater risk for both mental health and behavior problems.

Bullying can be prevented, especially through the power of a united community. Community-wide strategies can help identify and support youth who are bullied, redirect the behavior of youth who bully, and change the attitudes of adults and youth around bullying.

However, bullying doesn't happen only at school. Community members can use their unique strengths and skills to prevent bullying wherever it occurs. If youth hear anti-bullying messages from the different adults in their lives, this reinforces the message that bullying is unacceptable. Parents and youth also have a role in preventing bullying in school. When parents and youth are involved in the solutions:

- Youth feel safer and can focus on learning.
- Parents worry less.
- School climates improve.
- Parents can support schools' messages about bullying at home.
- Parents are more likely to recognize signs that a • child has been bullied or is bullying others.

There is still more to be done to build safer school environments for our youth. Parents and youth need to feel valued and be given opportunities to contribute their expertise and to be involved in meaningful roles. Community and family can work together to prevent bullying, so take time to be involved and help our youth build resilience!

A personal representative is someone who participates in a patient's health care. This could be a family member, caretaker, close friend. Personal representatives are responsible for helping manage a patient's health care and to make decisions for the patient. When officially designated, personal representatives can access the patient's protected health information (PHI) such as test results, and request medical records.

# Personal representative vs. health care agent

Personal representatives and health care agents both sign agreements to access medical information and make decisions for patients. However, the key difference is that health care agents may only do so when the patient cannot make their own decisions. For example, if they are unconscious or undergoing surgery, etc.

To designate or remove your personal representative, please Notice the HIM (Health Information Management) team and one of our representatives will be able to assist you. They will ask you to fill out a Personal Representative Form and will add it to your personal record.

What is Eczema? Eczema is a recurring skin rash characterized by itchy dry red skin, blisters, oozing, flaking and bleeding skin, its affects more than 31 million people. It develops in response to an overactive immune system that perceives certain triggers as a threat to the body's immune system.

Atopic dermatitis is the most common form of eczema. It is not contagious. Genes and the environment play factors as to who gets this skin condition and anyone is susceptible.

**Common triggers** There are several triggers for eczema these include: food allergies, soaps and perfumes, dust mites, certain fabrics and metals.

**Treatment** The best treatment for eczema may be determined by a doctor. There are many treatment options they include both oral medications and creams.
