## PUEBLO OF ISLETA RESOLUTION NO. 2024-103

### RESOLUTION AMENDING COMPENSATION FOR THE PUEBLO OF ISLETA ADMINISTRATION

At a duly called meeting of the Isleta Pueblo Tribal Council held on September 26, 2024 the following resolution was adopted;

**WHEREAS**, the Pueblo of Isleta (the “Pueblo”) is a federally recognized Indian Tribe organized pursuant to its Constitution adopted in accordance with the Indian Reorganization Act and with the inherent powers of self-government;

**WHEREAS**, Article V, Section 2(h) of the Pueblo of Isleta Constitution authorizes the Isleta Tribal Council to “prescribe compensations for the executive officer, employees, and members of the council;”

**WHEREAS**, Article IV, Section 4 of the Pueblo of Isleta Constitution authorizes that “[t]he executive officers shall be paid such compensation as the pueblo council may from time to time establish; provided, however, that the compensation for any executive officer shall not be increased or diminished during his term of office;” and

**WHEREAS**, the Tribal Council finds it in the best interest of the Pueblo of Isleta to amend compensation for the Pueblo of Isleta Tribal Administration to address the increased costs of living and encourage more individuals to run for office in the upcoming election.

**NOW THEREFORE BE IT RESOLVED**, effective January 1, 2025 Tribal Council hereby authorizes compensation for the following executive officers as listed:

- Governor \$154,460.80 a year
- First Lieutenant Governor \$120,203.20 a year
- Second Lieutenant Governor \$120,203.20 a year
- Sheriff \$30.00 an hour for hours worked
- Undersheriff \$30.00 an hour for hours worked

**BE IT FURTHER RESOLVED**, that the Treasury Department is authorized to do all that is necessary to implement the intent of this Resolution, including assistance with applicable timekeeping processes; and


**BE IT FURTHER RESOLVED**, that this Resolution shall remain in effect until otherwise superseded or repealed by Tribal law.
