#### Please complete application in full. For any question that does not apply please mark with N/A.

- 1. Enter business name of entity. If business is an individual's name, enter first name, middle initial, and last name.
- 2. If entity operates under a different name than the business name, list the name the business is "doing business as" (DBA).
- Enter Federal Employer Identification Number (FEIN). For Individuals, enter Social Security Number (SSN) or Individual Tax Identification Number (ITIN).
- 4. If your business will need a Non-Taxable Transaction Certificate, please provide your New Mexico State Tax ID number also known as a Combined Reporting System (CRS) ID number.
- 5. If applicable, enter Contractor's License or Professional Licensure Number, Issuing Organization, State within which the license is issued, and the date license was issued.

# Frequently Asked Questions (FAQ):

### Why must I register my company with the Pueblo of Isleta Treasury Department?

Any Person Engaging in Business within the Pueblo of Isleta Reservation must register with the Pueblo's Treasury Department in order to maintain compliance with the Pueblo's Tax Code and new Vendor procedures.

## Who must register?

Any Person Engaging in Business within the Pueblo of Isleta Reservation.

## Who is not required to register?

- Any Person that is not engaging in Business within the Pueblo of Isleta Reservation is not required to register.
- Any Person expressly exempted from registration by the Pueblo of Isleta.
